SUBJECT: **RAILS FINANCIAL REPORT – JULY 2017** 

Please find attached the RAILS Financial Reports for the month of July 2017. The attached statements include fund Balance Sheets for RAILS' General and Capital Projects Funds and the Statements of Revenue and Expenditure reports for RAILS' General Fund as well as for individual program reports, Delivery operations and LLSAP support. In addition, reports showing the details of RAILS' cash and investments and monthly expenditures are included. There was no financial activity during July within the Capital Projects Fund, as we have not yet received an invoice for Burr Ridge renovation work, and the Special Revenue Funds.

The July 31, 2017 unassigned General Fund (\$12.3 million) cash and investment balances, would fund an estimated 13.2 months of operations. RAILS has been awarded, but has not received as of this report date, \$3,962,120 of FY2017 Area and Per Capita Grant funds, which would fund approximately four months of operations.

#### **FY2018** Revenues and Expenditures

Total General Fund revenues of \$903,462 in July were \$712,326 below budget, as RAILS received no Area and Per Capita Grant revenues. These revenues are budgeted to occur throughout the year, but payments in actuality are irregular. Area and Per Capita revenues of \$823,260 were budgeted for July.

Total General Fund expenditures of \$1,080,313 were \$379,079 below budget. July typically is a low spending month as a significant percentage of expenditures made during the month pertain to the prior fiscal year.

Personnel expenditures were \$41,445, or 9.6%, below budget, of which \$22,868 were salary expenditures. The budget included not yet implemented general salary increases of 3%. In addition, two new budgeted positions were not yet filled and three vacated positions, one of which will not be filled, have not been replaced.

Contractual Services expenditures were \$213,355 below budget. Most expenditures made during July pertained to the prior fiscal year, and the variance will decrease as the year progresses.

There were no July Capital Projects Fund' expenditures as RAILS has not yet received its billing for the month. A payment of \$172,426.90, for June Burr Ridge construction, was made in July. We are expecting a higher amount for July construction activities.
