# RAILS Report

### **Find More Illinois**

At its meeting on January 26, 2018, the RAILS Board approved moving forward with the Find More Illinois pilot project. Twenty-one libraries from I-Share, PrairieCat, and Rock River Library Consortium are participating in the pilot. Implementation of the SHAREit software from Auto-Graphics began shortly after RAILS board approval. Staff training was held April 3–5, 2018 at RAILS Burr Ridge and Coal Valley, and staff at the pilot libraries will begin placing staff-initiated requests on April 16.

Libraries have been asked to launch the program to their patrons between May 1–31. Only pilot participants and their patrons will be able to actually place interlibrary loan requests, though anyone will be able to search. The Find More Illinois website and catalog search interface will be launched publicly early in May; watch for the announcement in RAILS *E-News*. Expansion of the project to additional libraries is expected to occur as soon as fall 2018.

At its first meeting on February 26, 2018, the RAILS Resource Sharing Committee approved the charge for a new Find More Illinois Working Group. This group will have an advisory role in developing best practices and a membership fee structure for future expansion of Find More Illinois. It includes representatives from each consortium participating in the pilot project and two representatives from libraries with standalone catalogs. Working group members are:

## **FY2019 LLSAP Support**

The FY2019 LLSAP/RAILS contracts with PrairieCat, RSA, and SWAN have been approved by the RAILS Board and LLSAP governing bodies and will be included in the RAILS FY2019 area and per capita grant application to the Illinois State Library. Target net support has been kept flat at \$2,250,000; it will be incorporated into the RAILS FY2019 budget as a mix of in-kind services and financial support, depending on the services used by the individual LLSAPs.

## **Explore More Illinois**

Development of Explore More Illinois continues. Basic configuration and testing of SIP2 authentication with a consortial Symphony ILS was successful. RAILS staff will continue working to ensure that libraries that are members of ILS consortia have a seamless onboarding experience once the service is ready to
