ABOUT: Approval to Use Job Order Contracting

Job Order Contracting (JOC) is a collaborative construction project delivery method that uses an "on-call" contractor with a fixed rate pricing structure. By awarding long-term contracts for a variety of projects through a competitive bidding process, JOC reduces overhead, saves staff time, and streamlines the procurement process while adhering to procurement policies.

The City of Naperville went through a competitive bidding process and hired F.H. Paschen as its JOC contractor. The city has also made its JOC contract available to public entities across the state. This contract began in 2011 and runs through June 2019.

Use of the City of Naperville's JOC contract would simplify future RAILS facility projects, such as the tuck-pointing needed for the Burr Ridge building. Included with this memo is a resolution authorizing RAILS participation, as well as an F.H. Paschen newsletter with additional background information.

We ask that the Board adopt the resolution to participate in the Job Order Contracting agreement awarded to F.H. Paschen by the City of Naperville.

# AUTHORIZING RAILS EXECUTIVE DIRECTOR TO NEGOTIATE AND EXECUTE PARTICIPATION AGREEMENT

WHEREAS, the Reaching Across Illinois Library System ("*RAILS*") is an Illinois Library System authorized to contract, and hold title to personal property for library system purposes (75 ILCS 10/7(8, 11)); and

WHEREAS, RAILS desires to enter a participation agreement with the City of Naperville for the purchase of a variety of goods, products, and services through competitive solicitation and selection; and

WHEREAS, RAILS finds it necessary and convenient to delegate to its Executive Director the authority to negotiate and execute all necessary applications, contracts, agreements, and such other documents on behalf of RAILS, in order to enter a participation agreement with the City of Naperville,

NOW THEREFORE, BE IT RESOLVED by the Reaching Across Illinois Library System Board of Directors, as follows:

**Section One.** *Recitals* 

The foregoing recitals are hereby declared to be the findings of the RAILS Board of Directors ("Board").

**Section Two.** *Executive Director Authority* 

The RAILS Board hereby authorizes its Executive Director to negotiate and execute all necessary applications, contracts, agreements, and such other documents to enter a participation agreement with the City of Naperville for the "Competitive Procurement RFP 11-082, Job Order Contract to F H Paschen/SN Neilsen."

**Section Three.** Force and Effect

This Resolution shall be in full force and effect from and after its passage and approval.

# METRA STATION ROOFING AND TUCKPOINTING

Naperville

F.H. Paschen recently removed the existing clay tile roof, originally installed in the 1940s, at the Naperville Metra Station and replaced with new asphalt shingles. Additionally, we completed masonry tuckpointing around the building. The building soffits and the ceilings of the exterior pedestrian waiting areas were also cleaned, scraped, and repainted. These projects caused minimal to no disruptions to the city's commuters.





# TRAIN STATION TILE REPLACEMENT

Downers Grove

Paschen removed and replaced the floor tile throughout the entire Downers Grove Train Station building, which included open public areas, miscellaneous side rooms, a ticket office, bathrooms, and barber shop. Paschen also installed three new floor drains with associated piping, and completed drywall patching where necessary. This project was phased in order to keep the majority of the station building open during construction.
