SUBJECT: FY2019 Certification Results

## **Certification Process**

The annual certification process requires that system members complete both the Interlibrary Loan (ILL) Traffic Survey [23 III. Adm. Code 3030.200 (a)(2)(0)] and the questions on the Illinois State Library's certification portal [23 III. Adm. Code 3030.200 (a)(2)(I)]. The portal opened on January 2, 2019 and closed on March 31, 2019.

RAILS informed members of the requirements through an alert on the RAILS website and through articles in multiple issues of RAILS *E-News*. As the deadline grew closer, the RAILS certification team (Emily Fister, Karen Goyer, Jody Rubel, and Margae Schmidt) also contacted (via email and/or phone) member libraries that had not already successfully certified to remind them of the deadline, to assist them as needed, and to follow up on unexpected responses (i.e. answering *no* to a membership requirement). I also assisted libraries that had unexpected responses or that requested withdrawal from RAILS membership. In addition, on March 27, Illinois State Library staff emailed login information to all libraries that had not yet completed the ILL Traffic Survey. (RAILS staff do not have direct access to ILL Traffic Survey information.) RAILS staff were also available by phone and email on the final weekend (March 30 and 31).

During the first week of April, RAILS and ISL staff compared information on libraries that had not yet completed the ILL traffic survey and/or the certification questions and made final attempts to work with these libraries.

## **Recommendations for Suspension**

By April 8, all but three RAILS libraries had successfully completed the ILL Traffic Survey and certification or had requested withdrawal. On April 9, the remaining three agencies were sent certified letters notifying them that the RAILS Board would be asked to recommend suspension of their RAILS membership. Their representatives were also invited to attend the board meeting on April 26, 2019. On April 16, one of these agencies successfully resolved its unexpected certification responses.

We ask that the RAILS Board recommend suspension of the following libraries to the Illinois State Library:
