8. New Business

a. Discussion of OCLC and the Illinois State Library

Illinois State Library Director, Greg McCormick and Suzanne Schriar, Associate Director reported that the most utilized OCLC group service is cataloging and its related products and WorldCat as the most used database.

Discussion moved to the value of FirstSearch. FirstSearch value extends beyond the databases and important for exposing holdings on the web. ISL staff explained that ISL offsets the FirstSearch subscription costs for libraries. Heavy users of FirstSearch are academic libraries, libraries that do not utilize group services, or not OCLC members.

Due to technical difficulties, there was an interruption and the meeting resumed at 1:16 p.m.

Next ILS staff reviewed that the current OCLC contract extends through FY2020-FY2021, with an optional three year renewal. It was suggested before renewing the contract to investigate tiered product subscriptions. ISL open to the idea, but would need to research contract terms, historical documentation, procurement protocol, and seek input from systems, and consortia. Understanding usage at a granular level would be beneficial in identifying needs.

9. Unfinished Business

a. Review and discussion of report introduction and draft report

The group reviewed both the introduction and report. Improvements to the report organizational structure were noted; add labeling to sections for clarity, and document inspected for missing or duplicate content subject areas. It was noted to add a graphic depicting a comparison of consortial holdings, Find More Illinois, SHARE Illinois, and OCLC and the role in interlibrary loan. Suggested stronger verbiage in the report recommendations section for explicitness.

Coulter and Slaughter will review and combine the report documents for the September 16, 2019 working group meeting. The Project X summary needs to added to the report.
