### SUBJECT: RAILS FINANCIAL REPORT – SEPTEMBER 2019

Please find attached the RAILS Financial Reports for the month of September 2019. The attached statements include the individual fund Balance Sheets and Statement of Revenue and Expenditure reports for RAILS' Governmental (General, Special Revenue and Capital Projects) Funds, plus separate reports for two major programs, Delivery operations and LLSAP support. In addition, reports showing the details of RAILS' cash and investments and monthly expenditures are included.

The September 30, 2019 unassigned General Fund (\$14.7 million) cash and investment balances would fund an estimated 15.6 months of operations. Cash and investment balances decreased \$0.1 million from the August 31, 2019 balance as RAILS received an Area and Per Capita (APC) grant payment of \$417,388 during September. An additional APC grant payment of \$1,518,756 was received in early October. Three vouchers of \$1,072,500 each pertaining to the FY2019 APC award remain outstanding.

### FY2020 Year-To-Date Revenues and Expenditures

Total General Fund revenues of \$1,488,667 through September were \$2,139,509 below budget primarily from lower APC Grant revenues (\$2,079,002 below budget), and below budget Reimbursements (\$89,126). Investment income of \$103,491 through September was \$4,041 above budget. Investment income for September was \$2,066 below the August amount, which in turn was \$4,611 below the July amounts. September month end interest rates declined .03% and .19% from the prior month end rates for the Illinois Funds and Hinsdale Bank Money Market accounts, respectively.

Total General Fund expenditures of \$2,992,030 were \$288,139 below budget due primarily to lower Contractual Services (\$108,730), Library Materials (\$99,865) and Personnel (\$57,784) expenditures, partially offset by above budget Equipment Rental, Repair and Maintenance expenditures (\$61,878). Contractual Services expenditures were lower as budgeted expenditures for Catalog Membership grants and delivery contractual services have not yet been incurred. Equipment Rental, Repair and Maintenance expenditures for services covering the entire fiscal year were paid in July.

Personnel expenditures were \$57,784, or 4.8%, below budget, of which \$47,504 were salary expenditures. The lower than budget salaries were due primarily to three budgeted open positions, one of which has now been filled.

For the month of September, RAILS had one new hire (Jaimie Buckman, Member Services User Experience Coordinator, RSA) and two terminations (Jim Smith, Driver, East Peoria and Matt Leaf, Driver, Coal Valley).

(Terminations refer to all persons leaving RAILS employment for any reason, including resignations and retirements).

During September, RAILS received the funding (\$28,710) for the FY2020 Marc of Quality Grant. The expenditures for this program will be incurred later in the fiscal year. Other future activities within the Special Revenue Funds will be derived primarily from the L2 replacement grant, and other grant programs which may arise.

All of the budgeted Capital Projects Funds expenditures occurred during September. RAILS for FY2020 budgeted for the purchase of seven delivery vans totaling \$179,500 and purchased these vehicles at a total price of \$185,500 in September. The additional costs over budget were primarily due to the inclusion of bulkheads in each vehicle, as a driver protection measure. In addition, RAILS budgeted \$35,000 for the purchase of a storage server and made this purchase in September at a cost of \$24,224.

Delivery department expenditures of \$789,526 through September were \$88,017 below budget primarily from lower contractual services (\$45,682), along with below budget expenditures in several other expenditure categories. Contractual services expenditures were below budget primarily as two weeks of billings pertaining to September services were not paid until October. Delivery department expenditures through August were 26.4% of total General Fund expenditures.

LLSAP support expenditures of \$504,379 through September were \$42,550 below budget, due primarily to lower than budget personnel expenditures due to unfilled vacancies, and were 16.9% of total General Fund expenditures.
