SUBJECT: Executive Director Report – October, 2019

Promote, support, and expand resource sharing to optimize use of tax dollars and other funding and help libraries share resources to the fullest extent possible

We heard today that we are a successful applicant for the IDHS Census 2020 grant. RAILS will be awarded \$750,000 for work to promote a complete count.

We are very pleased at this opportunity to work with libraries and other partners on this critical project. I will provide detailed information at the board meeting.

Work with libraries of all types to tell the library story

We have met twice with *Imagination* to finalize the script for our next video. We are hoping to get this filmed and available for the ILA legislative meet-ups next spring.

The *My Library is ... Campaign* was a very popular service at the AISLE (Association of Illinois School Library Educators) conference in Springfield last week, October 10-12.

My most recent podcast was with Brian Shepard, Director of the Indian Trails Public Library District and ILA's Librarian of the Year 2019.

Help libraries be the best they can be

At the PPC and Advocacy committee meetings on Monday, October 7, attendees discussed legislation and ideas for the ILA legislative agenda.

The State Library has filed amended language to Senate Bill 585 (attached). This bill was filed in response to patron complaints that self-pick-up of holds violates patron privacy and the Illinois Library Records Confidentiality Act. As Julie Tappendorf reported to us at the September board meeting, the self-pick-up of holds process should protect patron confidentiality through the use of a patron "code" that will anonymize patrons and their checkouts.

We also discussed what our legislative "ask" should be this year, and agreed to look into requesting funding to provide statewide database access (meaning funded centrally by state dollars) for all system member libraries as this would produce savings locally for libraries. We also discussed possible relief for libraries as they begin to deal with the increases in the minimum wage.

We also discussed the legislation that Ancel, Glink drafted at the request of RAILS, that will somewhat ease the process for municipal and village libraries to merge into or form library districts.

There will be further discussion at the November 4 Policy and Advocacy committees. Hopefully, the committees will vote to move forward on these initiatives so they can be filed with the legislature at the appropriate time.

Prepare libraries for the future

At our member update on October 3, one of the topics for discussion was our recent survey of libraries about services they offer to the unserved. We did this survey as part of our work with the Universal Service Committee. The conversation about the survey developed into a general conversation about the laws and rules governing non-resident library cards including fees for cards, what services non-residents are eligible for and the "commonality of community interest" clause in the Administrative Rules. We will be working with the State Library to develop an FAQ to help libraries navigate these very confusing areas. We will also be developing some training for member libraries and additional web resources.

Aim to be the best library system in the country

The Board policy committee had a very productive meeting on October 16. We established a process for reviewing in the employee handbook, and worked our way through almost half of

the policies. There were some questions, which we will forward to our attorneys, and some suggested changes as well. We also established a schedule for future meetings. We hope to complete the review by March so that the full board can review and approve the policies, and then forward to the State Library for final approval.

AMENDMENT TO SENATE BILL 585

AMENDMENT NO. _____. Amend Senate Bill 585 by replacing everything after the enacting clause with the following:

"Section 5. The Library Records Confidentiality Act is amended by changing Section 1 and by adding Section 5 as follows:

(75 ILCS 70/1) (from Ch. 81, par. 1201)

Sec. 1. (a) The registration and circulation records of a library are confidential information. No person shall publish or make any information, including but not limited to a patron's personal identifiable information, contained in such records available to the public unless:

- (1) required to do so under a court order; or
- (2) the information is requested by a sworn law enforcement officer who represents that it is impractical to secure a court order as a result of an emergency where the law enforcement officer has probable cause to believe that there is an imminent danger of physical harm. The information requested must be limited to identifying a suspect, witness, or victim of a crime. The information requested without a court order may not include the disclosure of registration or circulation records that would indicate materials borrowed, resources reviewed, or services used at the library. If requested to do so by the library, the requesting law enforcement officer must sign a form acknowledging the receipt of the information. A library providing the information may seek subsequent judicial review to assess compliance with this Section. This subsection shall not alter any right to challenge the use or dissemination of patron information that is otherwise permitted by law.
- (a-5) A library may not put any part of a patron's last name on material that has been reserved by a patron to check out if the material can be viewed by other persons in the library.
- (b) This Section does not prevent a library from publishing or making available to the public reasonable statistical reports regarding library registration and book circulation where those reports are presented so that no individual is identified therein.
- (b-5) Nothing in this Section shall be construed as a privacy violation or a breach of confidentiality if a library provides information to a law enforcement officer under item (2) of subsection (a).
- (c) For the purpose of this Section, (i) "library" means any public library or library of an educational, historical or

eleemosynary institution, organization or society; (ii)
"registration records" includes any information a library
requires a person to provide in order for that person to become
eligible to borrow books and other materials and ;(iii)
"circulation records" includes all information identifying the
individual borrowing particular books or materials; and (iv) "personal
identifiable information" means, individually or collectively, a
patron's complete last or first name, address, internet protocol
address, social security number, complete telephone number, email
address that directly identifies an individual.

Sec. 5. Violations. A person or entity that violates any provision of this Act commits a petty offense for which a fine of \$100 may be imposed for each violation.".

Leading/Working with Libraries to Expand Resource Sharing



Frankfort Public Library District and Winfield Public Library are now participating in Find More Illinois. Frankfort is the first SWAN library to join, following the development of OpenAthens authentication for Find More Illinois to meet SWAN's requirements. Because Winfield has a VERSO integrated library system from Auto-Graphics (the vendor of the SHAREit software that runs Find More Illinois), it enjoys additional integration between its VERSO system and SHAREit.

Providing Access to Digital Content/E-Resources/Other Innovative Projects

E-Content Publisher and Pricing Issues

RAILS hosted a meeting on September 30 for e-content consortia and sharing group managers to discuss publisher restrictions on library e-content and other recent developments. Fourteen people attended. We had a productive discussion, and the group decided to meet regularly in the future. The next meeting is scheduled for January 14, 2020. RAILS also created an Electronic Content email list at the request of the group.

We also created a <u>web page</u> in the new Library Pulse section of the RAILS website on e-content issues. (See further information below.)

BiblioBoard Update

RAILS launched <u>inkie.org</u> to all libraries on October 1. The response has been very positive. Galena Public Library reached out and asked us to do a presentation on inkie.org at Galena LitFest in January. RAILS Board members attending the upcoming Illinois Library Association (ILA) conference are invited to stop by the RAILS booth to receive an inkie.org tattoo.



Anna Behm, RAILS E-Content Specialist, presented "Free E-Books and More, Available All the Time" at the Association of Illinois School Library Educators (AISLE) annual conference on Saturday, October 12. Anna spoke about BiblioBoard, and specifically the RAILS for Schools BiblioBoard site (https://railsforschools.biblioboard.com/home), as well as inkie.org.

eRead Illinois

Baker & Taylor provided RAILS with access to a test version of the newly redesigned Axis 360 app. The app represents a major improvement over the current app with changes to the search, browse, design, and overall performance. This app represents a very positive step for Axis 360, and we look forward to continued improvements over the coming weeks.

RAILS CE to Help Libraries Tell Their Stories

RAILS recently offered several continuing education (CE) opportunities related to our My Library Is... campaign. During the last week of September, Pat Wagner of Pattern Research, Inc., presented identical workshops at Chillicothe Public Library and Fountaindale Public Library on creating a marketing plan. These workshops provided a framework for some of the more focused marketing-related CE events that will follow as we move forward with the campaign.

On October 1, RAILS' own Grant Halter, Data Coordinator & Research Analyst, presented a webinar introducing participants to Google Data Studio. In this finale to our very successful "Making the Most of Your Library Data" series, Grant demonstrated how libraries might utilize Google Data Studio to present their data in visually-appealing dashboards.

On October 9, Barbara Alvarez presented a webinar titled "Facts Tell, Stories Tell: Marketing Your Library's Message." Participants learned how to incorporate storytelling into their library's marketing strategy and how to tailor their message to specific stakeholders.

All four of these CE events were very popular with members, with a total of 224 participants.

Library Pulse Section of RAILS Website Features Content on Important Library Issues

There is a new section on the <u>RAILS homepage</u>, called The Library Pulse. 
RAILS Member Update
