SUBJECT: Executive Director Report – December - January, 2019

Promote, support, and expand resource sharing to optimize use of tax dollars and other funding and help libraries share resources to the fullest extent possible

Ebooks and related issues at ALA: RAILS staff (Leila Heath, Monica Harris and Anna Behm) attended ALA midwinter where they focused on ebook and related issues. They met with Baker and Taylor to continue discussions about improvements to the App. They also attended meetings of Readers First, the Ebook consortial interest group and the DPLA SimplyE advisory committee.

We have been discussing the App with Baker and Taylor for a year now. It is not a stable App and although a lot of work has been done to improve it, it still is not where we would like it to be. We are seriously considering looking at other vendors for eRead, including issuing an RFP to potential vendors. We have informed Baker and Taylor about this. Given that the app is the primary way that patrons access the eRead collection, we are concerned that eRead does not get the use it should because the App is a barrier, not an effective portal.

IMLS: I expect that you have already heard the news that for the 4th year in a row the proposed federal budget de-funds the Institute for Museum and Library Services. IMLS issued <u>a statement</u> as did <u>ALA</u>. As we have discussed during the past three years, IMLS provides funding for libraries to all fifty states, and supports system services including delivery.

Work with libraries of all types to tell the library story

Elders of the Internet: Our video launched last week! An extensive publicity campaign centered around Library Lovers Month (February) and Library Lovers Day (February 14) is underway. Nick

Offerman, famous for his role as Ron Swanson in *Parks and Rec*, is the star of the *Elders*. We are grateful to Nick and to his sister, Lauren Offerman, director at Three Rivers Public Library District, for their assistance and support of this project.

Advocacy talking points: Mary is working with Marci Merola, formerly head of the advocacy office at ALA, on talking points for all types of libraries to use when telling their stories to funders, legislators, users and other stakeholders. Members of AISLE are assisting us with the talking points for school libraries, and academic, special and public librarians are assisting us with points for these libraries. We will share with the board when they are finished.

AISLE: We are continuing our meetings with AISLE, having held one each in January and February. We continue to discuss training and other issues we share. There is a full report in *This Month at RAILS*.

As you know, we are trying to forge a closer relationship with AISLE so we can be better informed about school libraries and better able to assist them. We had a good conversation about how RAILS can be helpful to AISLE in the areas of training, chapter development and advocacy. We are going to investigate how we might collaborate with AISLE to offer PDH (professional development hours) credits.

Legislative meetups: Thanks very much to the RAILS staff and board members who have attended the ILA meetups. These meetups are a great opportunity to talk to legislators about the importance of libraries and RAILS, to hear about ILA's legislative priorities and to establish relationships with trustees and other library advocates in attendance.

Help libraries be the best they can be

Certification: The annual certification process for all system members began on January 2, 2020 and ends on March 31, 2020. We anticipate that it will go very smoothly this year thanks to improved access to online reports (thanks to the Illinois State Library) and work that Grant Halter has done to make existing data about libraries more accessible for our administration/certification team. The process will be even more streamlined next year because libraries will use L2 to complete the process.

Podcast: I recorded my latest podcast in January. My guest was Amy delaFuente and we discussed the census and the many interesting and creative projects and programs that libraries are undertaking to ensure a complete count in Illinois.

Forreston Public Library visit: I visited the Forreston board of trustees the evening of January 29 to talk to them about hiring a new library director as well as all of the programs that RAILS offers to trustees. This library has a budget that is less than \$40,000 per year and a staff of 2 part-time people. They have a very nice building despite the low budget, having done some fundraising a few years ago. They hope to do more fundraising so they can increase programs for the community. Here is part of a note that one of the trustees sent to us:

"I would like to thank you for visiting with our board. Just having someone else see and understand what we are working on here gave us all a sense of relief. I have already spoken with Carolyn, at PrairieCat, and we have come up with a plan moving forward. We are coming together as a board and it is just so wonderful to see and be a part of. I greatly appreciate you and your program. I can't wait to show you how far Forreston Library has come, and will continue to improve. We are familiarizing ourselves with RAILS website and have even watched some of the webinars."

It is so rewarding to help these under-resourced libraries, to see all that they want to do for their communities and to raise their awareness of how RAILS can help.

Prepare libraries for the future

Data Consulting Visits are a new training service RAILS is exploring to offer a hands-on approach to building a data culture at our library members. Grant Halter, Data Analyst at RAILS, recognizes the challenge members have applying data concepts and techniques learned from a presentations and webinars to their own situations. These Data Visits provide personalized data culture training through on-site consultations with members to address any data-related concerns and create a plan to use data more effectively and efficiently.

In January, Grant visited Rockford Public Library where he met with Executive Director Lynn Stainbrook and other staff to review their data culture and discuss how they can better implement data in their work. The group worked on gaining a deeper understanding of writing value statements by applying a data-focused logic model and how to connect data collection and analysis work with the strategic initiatives.

RAILS staff expect this service to be in high demand and are currently looking into the best way of offering this service to members or all types and sizes.

Aim to be the best library system in the country

March meeting: Our March 27 board meeting will take place at University of Illinois at Chicago Richard J. Daley Library. Of course, it will also be available via teleconference at the usual sites. Gwen Gregory is arranging a tour and we will have lunch, as usual. We will work out logistics related to parking and transportation and provide full information in advance of the March meeting.

Find More Illinois Continues to Grow!

<u>Find More Illinois</u> provides a single discovery interface that draws from the online catalogs of participating libraries. Anyone can search multiple Illinois library catalogs at once. Patrons and staff of participating libraries can log in to place interlibrary loan requests. Over 3 million items are currently available through Find More Illinois.

Five high school libraries, one academic library, and over 30 public libraries now participate. Our newest members include: Bloomington Public Library, Cambridge Public Library District, Clinton Township Public Library, Frankfort Public Library District, Hometown Public Library, Walnut Public Library District, and Winfield Public Library. Additional new libraries are always welcome!

Providing Access to Digital Content/E-Resources/Other Innovative Projects

Inkie.org Continues to Grow in Popularity

<u>Inkie.org</u> has been generating a lot of interest among Illinois libraries and library users. RAILS staff have given a number of presentations about this self-publishing suite of resources in recent weeks, including at <u>Galena LitFest</u>, PrairieCat Delegates Day, the Warrenville Public Library writer's group, and at a visit to Elizabeth Township Public Library.



Anna Behm, RAILS E-Content Specialist, also participated in a panel discussion at Chicago Public Library about the <u>Indie Author Project</u> and inkie.org on January 17. Representatives from BiblioBoard and <u>Soon to Be Famous Illinois Author project</u> winners were also part of the panel.

Approximately 50 people attended and raised several excellent questions and discussion points.

eRead Illinois Update

RAILS recently added all available <u>2021 Rebecca Caudill Young Readers' Book Award titles</u> to the <u>eRead Illinois</u> collection. We also continue to monitor the demand for popular titles, including

new Macmillan releases. RAILS also plans to revise and simplify the sign up and renewal procedures for eRead Illinois this spring.

ALA Midwinter Conference Features Many Discussions on E-Resources

Three RAILS staff members attended the American Library Association Midwinter Conference in Philadelphia, January 23 – 27. Many meetings focused on e-content issues. Highlights included:

- John Sargent, Macmillan CEO, <u>answering questions from concerned librarians</u> about Macmillan's eight week embargo on new e-book titles
- An update on the American Library Association's #eBooksForAll campaign and news of possible action at the federal and state government levels to protect e-lending in libraries
- An update on the Digital Public Library of America (DPLA) and SimplyE

Other E-Resources Highlights

Over 30 people attended the January quarterly RAILS E-Content Meeting. There was a good discussion about the state of e-books in RAILS member libraries and other related issues.

RAILS staff participated in a conference call with the Hachette Book Group, one of the "Big Five Publishers." Each of the five have different terms, conditions, and pricing for library e-books. Some, including Hachette, have recently adopted more restrictive and expensive licensing terms for libraries. Hachette reached out to RAILS to discuss e-content challenges libraries currently face, as well as goals and opportunities around digital content in public libraries.

RAILS staff attended the January Electronic Subscription Managers Network Group (ELSUM) meeting at Barrington Public Library District. As a result of the meeting, RAILS is working on a web page on data privacy that will be available to all members in April. Stay tuned for further details.

Explore More Illinois Update



A total of 249 libraries currently participate in our <u>Explore More Illinois</u> statewide cultural pass program. The <u>American Writers Museum</u> in Chicago is the newest of 29 attractions. RAILS staff recently gave presentations about Explore More at the PrairieCat Delegates

Assembly and the Circulation Managers Roundtable in Lincolnshire.

Fostering Networking & Collaboration

RAILS and IACRL to Co-Host Spark Event

On Friday, May 15, RAILS and the Illinois Association of College & Research Libraries (IACRL) will co-host a peer-to-peer learning event called Spark: Connect and Get Fired Up! This one-day

event will include lightning talks, breakout tables, and a chance for academic libraries in Illinois to learn more about trends in the field. Staff members from all Illinois libraries are invited.

New RAILS Video Debuts!


RAILS has been working with the Imagination marketing firm on a new video as a part of our My Library Is... campaign. This is a follow-up to the very popular "Dreams Take Flight" video.

It stars Nick Offerman, who is best known for his role in the *Parks & Recreation* sitcom. RAILS officially rolled out the new video on February 14 (Library Lovers Day) with an extensive social media and publicity campaign, and we will continue to promote it on an ongoing basis. The Illinois Library Association is also showing the video at their legislative meetups. My Library Is... Facebook Challenge Results



In January, RAILS held a week-long social media engagement campaign to increase awareness of our My Library Is... campaign. We invited members to share talking points, marketing plans, social media posts, and other efforts to tell their library's story. Every day, a new prompt was posted on the RAILS Facebook page.

Overall, there were 26 comments and 10 likes for the seven individual posts. Our goal statistics appear below. Although we missed the Weekly Total Reach target, RAILS surpassed its Daily New Likes total and barely missed the target for Daily Engaged Users. The 44 Daily New Likes represent the highest total for any one month since RAILS began its Facebook page.

Advocating for and Helping Members Advocate for Libraries

Working with AISLE to Advocate for School Libraries

RAILS is partnering with the Association of Illinois School Library Educators (AISLE) Executive Board and the Illinois Heartland Library System (IHLS) to develop ways to advocate for school

libraries and to provide and promote CE opportunities for school librarians. We have had three meetings via Zoom thus far. The latest meeting was on February 12. Topics discussed include:

- How RAILS and AISLE can work together to promote the My Library Is... campaign and the talking points for school libraries that RAILS is currently working on (in addition to talking points for academic, public, and special libraries)
- The results of a recent AISLE survey on school professional development needs and how RAILS can help via our CE offerings
- Collecting better data on how many school districts in Illinois have a library and how many have a full-time certified librarian
- Developing a school leader collaborative and identifying administrators who support school libraries

RAILS CE Event Grant Funds Event for School Librarians

A "Thoughtful Planning Supports Student Learning" workshop was held on January 31 at the Garfield Park Office of Chicago Public Schools (CPS). Funded by a RAILS CE Event Grant, the daylong workshop focused on developing an action plan to show progress toward achieving stateendorsed standards and supporting student learning.



There were about 40 attendees, with a near 50/50 split between CPS and non-CPS librarians. Several remarked how valuable it was for CPS and non-CPS librarians to network, and asked RAILS to offer additional opportunities in the future. With participants traveling from as far away as Moline, we hope to replicate this workshop at another RAILS location in the spring.

Certification Update

All RAILS member libraries are required to complete an annual online certification process to continue to receive system services (delivery, CE, etc.) and to qualify for Illinois State Library grant programs. The deadline is March 31, and libraries must also complete the ILLINET Interlibrary Loan & Reciprocal Borrowing Statistical Survey.

The RAILS Certification Team is working hard to contact and work with RAILS libraries of all types to ensure they complete the process in time. The following are completion statistics as of February 12:

Traffic Survey:

70% of all libraries have completed the traffic survey with this breakdown by library type:

- Academic 63% completed
- Public 75% completed
- School 73% completed
- Special 58% completed

Certification:

65% of all libraries have completed the entire certification process:

- Academic 54% completed
- Public 67% completed
- School 69% completed
- Special 53% completed

Serving Our Public 4.0 Available at Discounted Price for RAILS Members

RAILS has copies of *Serving Our Public 4.0: Standards for Illinois Public Libraries, 2020* available at a discounted price of \$25 each (includes shipping). The book offers help to public libraries in completing applications for state grant programs and also includes a CD. The book is also a great resource for trustees and library boards.

RAILS members can purchase the standards through the <u>RAILS website</u>. The cost is \$50 when purchased through the Illinois Library Association (ILA), \$30 for ILA members. As of February 12, RAILS has received orders from 40 libraries for 120 books.

RAILS Social Media Survey

The RAILS Social Media Team created <u>a brief survey on social media usage and member libraries</u>. The results of the survey will help the team focus messaging and tailor content to specific platforms. All library staff from all RAILS member libraries are invited to take the survey by February 28.

Engaging in Innovative Projects on Statewide & National Level

SimplyE Update

RAILS currently participates in a pilot grant program for SimplyE, a library-developed, open source eReader and eBook discovery app that simplifies the library user's experience in finding, borrowing, and reading e-books. For libraries with multiple e-book collections, it provides a single patron interface using the free SimplyE e-reading app for both IOS and Android devices. Without this interface, patrons would have to search the library's different e-book collections separately.

Until recently, OverDrive audiobooks were not part of SimplyE, which was a deal-breaker for participating in the project for most libraries. In January, OverDrive signed an agreement to include audiobooks. RAILS is now exploring costs and strategies to implement the program and will invite additional libraries to expand our pilot program.
