**SUBJECT: Executive Director Report – September, 2021** 

My report is very short this month because I was on vacation. However, I have included the first quarterly progress report on my goals in the packet.

#### Resource sharing – legislative proposals

At the August 30 meeting of the ILA Public Policy Meeting I presented 3 legislative proposals; statewide database funding; removal of an obstacle to public library mergers; and expansion of the Cards for Kids Act. PPC members were then polled about their priorities and the vote was as follows:

Databases 58
Broadband 57
E-book pricing 56
Levy & general fund 48
OMA training 44 (tie)
Cards for <18 44 (tie)
Mergers 29

Their recommendations now go to the ILA Executive Board for a final decision.

#### **Hugh C. Atkinson Memorial Award at ILA Conference**

As I reported previously, RAILS has been awarded the Hugh C. Atkinson Memorial Award by ILA. I recorded a short "thank you speech" this week, which will be included in the ILA Awards Ceremony on October 14 at 4 pm.

## **Universal Service**

My vacation has interrupted our discussion and agreement on a board statement urging statewide collaboration to extend library service to all residents. At this point, I plan to create a draft statement for the board to review at the October meeting.

#### Web Accessibility: VPAT Project for RAILS Public Libraries

RAILS has a Web Accessibility Voluntary Product Accessibility Template (VPAT) web page to help public libraries understand web accessibility and how to vet resources. This project fits in well with RAILS EDI efforts, as digital technology accessibility is essential when considering library purchases to achieve equitable and inclusive service and access to resources. Members can view the VPATs and easily create a customized VPAT page for their library.

#### **eRead Illinois Update**

RAILS staff have been analyzing <u>eRead Illinois</u> usage statistics by library to help inform future development opportunities.



We've also fielded an increased number of questions and support requests from eRead Illinois school library members returning for the new academic year.

#### **Use of RAILS E-Resources**

RAILS' <u>eRead Illinois</u> Axis 360 collection includes e-books and e-audiobooks for adults and children with very reasonable pricing. The <u>BiblioBoard Library</u> is available to everyone in Illinois, courtesy of RAILS, regardless of whether they have a library card. The following tables show use of these e-resources in August and for FY 2022 thus far.

#### **Explore More Illinois Update**

<u>Explore More Illinois</u> is RAILS' online cultural pass program. As of this writing, 392 Illinois libraries participate (319 RAILS and 73 IHLS member libraries), and there are 28 attractions.



New attractions include Butterworth Center and Deere-Wiman House in Moline and Museum of the Grande Prairie in Mahomet. We also recently added our first out-of-state attractions: Civil War Museum, Dinosaur

Discovery Museum, and Kenosha Public Museum, all in Kenosha, Wisconsin. See <u>complete list</u> of attractions.

RAILS staff met with <u>CARLI</u> (Consortium of Academic and Research Libraries in Illinois) staff on August 26 to further discuss steps towards potentially expanding Explore More Illinois to community colleges.

On September 8, Jessica Barnes, RAILS Special Projects Librarian, spoke to 11 attendees at the monthly meeting of the Illinois Association of Museums about opportunities for participating as an Explore More Illinois attraction.

### **ConsortiaManager Update**

ConsortiaManager (CM) is an online resource that helps increase efficiency, capacity, and member communications related to group purchases. As previously announced, RAILS staff began CM weekly training on September 2 and will continue through October. The training process includes building the content needed to create a robust site for those managing and participating in RAILS discount offerings.

RAILS staff also attended the CM User Group Meeting on August 25 to learn more about new and upcoming enhancements and user experiences. Over 40 consortia subscribe to CM worldwide.

In addition, RAILS also received a request to schedule a special "Introduction to RAILS" for Chicago Public School librarians, and we are following up on this.

SUBJECT: Executive Director Goals for FY 22 - progress report Quarter 1

As requested, here is the first quarterly project report on my goals.

Goal 1: Work with board, staff and members to develop a new strategic plan for RAILS that will be flexible, aspirational and practical, and will guide and help RAILS member libraries to provide innovative and essential services for their users.

Work on the strategic plan has begun on a couple of fronts; the board had their first brainstorming session with Stephanie and Cindy at the August meeting and future sessions are being scheduled. The first meeting of the Steering Committee was on September 16 and multiple town hall meetings with members have also been scheduled. Stephanie will be the main speaker at the RAILS member update on September 30. Stephanie and Cindy also held their first meeting with RAILS staff to introduce them to the process and get their initial ideas on goals.

#### Goal 2: Continue advocacy work for statewide database funding.

I presented three proposals to the ILA PPC meeting on August 30, and the statewide databases funding was voted the top committee priority, and it now goes to the ILA Executive Board for approval. We will work with ILA and the state library on next steps, and continue our own advocacy efforts.

Goal 3: Ensure that RAILS is financially stable; investigate revenue streams, increases to the APC grant, restructuring and other ways of being more efficient and economical while still providing needed services to members.

We have submitted 2 grant requests to the state library for funding of RAILS L2 work and the special cataloging of world languages in FY 2022. The total amount requested is \$164,406. We are also reducing our expenditures on the Biblioboard platform, focusing on the most used resources and the Illinois author aspect which is most important to our users. We are continuing to look at other expenditures and revenue streams as well.

Goal 4: Continue to work on the EDI initiative; improve RAILS internal culture, work with board EDI committee to meet the needs of members; establish a cohort of libraries to receive training; infuse EDI into all aspects of the strategic plan and the process to create the plan.

Work is continuing and excellent progress is being made. The staff Climate Team has set priorities and developed projects and timelines. The Board EDI subcommittees are also working on specific projects and we are having discussions with our consultant Biz Lindsay-Ryan about the development of a member library training cohort, hopefully to launch next March. We will schedule a full report to the board about all of our EDI work and progress in the coming months. We also awarded seven EDI training grants to member libraries to support CE programs that would also be available to other libraries.

Goal 5: Continue advocacy efforts for all types of libraries, and for multitype collaboration. Expand advocacy committee to include members and work closely with ILA, IHLS and AISLE.

Michael Campbell has taken over as chair of the Advocacy Committee. We have not yet reached out to possible additional members of the committee.

Goal 6: Identify data needs of member libraries and provide services to meet them as appropriate.

Not much to report on this goal yet as Grant has been mostly focused on internal data work related to the E-Read formula, the E-Read grant and certification.

# Goal 7: Continue to grow cooperative purchasing program and investigate revenue opportunities.

Leila continues to grow this program with recent additions such as Consortia Manager, a tool which streamlines the group purchases process and enhances capacity and efficiency for RAILS, and VPAT, or Voluntary Product Accessibility Template, which will aid member libraries in ensuring their websites are accessible.

Goal 8: Focus on the needs of school libraries; add specific questions to certification; work with AISLE, ISL and IHLS to gather complete and accurate data about school libraries in Illinois.

We had a good meeting with IHLS and the state library in August where we agreed to develop additional questions for school libraries for certification next year for both RAILS and IHLS. We think this will greatly increase our understanding of school library budgets and staffing, and the effects of the pandemic. We will work AISLE, ISL and IHLS to improve our school library data overall; the state library has expressed willingness to fund this work. We continue to meet monthly with AISLE, ILA, IHLS and the state library; we started these meetings a little over a

year ago and the collaboration and regular communication is really having an impact on our understanding of school library needs and AISLE awareness of RAILS services to school libraries. For example, we have been receiving requests from school libraries for one-on-one virtual visits with our Engagement Manager to better understand RAILS services.

# Goal 9: Continue efforts to identify technology and other methods that will modernize delivery services and bring financial efficiency.

We are continuing to analyze the results of the RFP for delivery services and automation that we issued earlier this summer. We plan to report to the board at an upcoming meeting.

#### Goal 10: Develop closer relationships with IHLS and CPL.

Our regular meetings with AISLE have enhanced our relationship with schools generally, including the Chicago Public Schools. Staff there have expressed interest in our board school library seat and staff at CPS libraries recently attended an EDI committee meeting. IHLS Executive Director Leslie Bednar will be attending the LLSAP Sustainability Working Group meeting next week and we will be working together on additional questions to include for school libraries next year in certification. We are also working closely together on policies related to vaccines, masking, and COVID testing.

# Goal 11: Restructure the Finance and HR departments, as appropriate to provide excellent financial stewardship and appropriate leadership of the finance and HR work at RAILS.

Human Resources staff are now reporting to Monica Harris, freeing up Jim Kregor to focus on projects leading up to his retirement. The Director of Finance job has been posted and will close in mid-October. We hope to begin interviewing soon after that. Additional retirements are expected in Finance next spring after the hiring of the new Director.
