## 6. Identity, Culture and Bias Training

EDI Consultant, Lindsay-Ryan went through an exercise using an identity wheel to have members list their identities and how those identities influenced them. Several committee members shared their responses. A TED Talk video was shown titled *The Danger of a Single Story*. Several of the statements from the video were reviewed and discussed. Lindsay-Ryan encouraged the members to think about what assumptions they have made about others with having limited information about them. The training included a review of the three culture levels listed on a culture tree diagram: surface culture, shallow culture and deep culture. Each level of culture was discussed and examples were given. The next part of the training reviewed individualism and collectivism on the topic of culture. The committee completed an exercise on culture, and several committee members shared their answers. Two videos on bias and blind spots was shown. A list of twenty cognitive biases was reviewed including anchoring bias, bandwagon effect, blind-spot bias, and zero-risk bias. The last video showed examples of different types of biases. The committee members selected three biases which they specifically struggle with and several people shared them with the group. Lindsay-Ryan closed the training with a discussion on inclusion and belonging and the benefits of inclusion.
