RAILS Board Committee Reports

Advocacy Committee Report- Chair Robin Helenthal

The committee met on October 13, 2022. The next meeting is November 10, 2022 at 4 pm.

The committee met on October 13, 2022. A prioritized list of committee goals was reviewed. Brennan explained that each month the committee will focus on one goal. RAILS will provide talking points. Committee members will then have the opportunity to use their networking connections or other venues to advocate for the topic and provide feedback on the advocacy efforts. The feedback will help to determine if the talking points are the right approach. Find More Illinois talking points were discussed. Brennan shared that based on past conversations with specialized librarians about advocacy, it is important to keep in mind that special libraries vary greatly.

Resources proposals to the ILA Board. Harris reported the ILA Advocacy Committee is working out options for the Legislative Meetups. ILA asked the Secretary of State candidates to share their perspectives on libraries in the form of a questionnaire. The responses have been posted on the ILA website.

RAILS Staff and RSA reported on their ongoing efforts towards greater independence and sustainability for the RSA organization. Monica Harris gave an update on the Resource Sharing Committee. Anne Slaughter reported Find More Illinois is experiencing steady growth. Activity is up 53% and holdings have doubled to approximately four million since last year. Find More Illinois is also receiving a lot of interest from schools. Deirdre Brennan highlighted Universal Service Committee efforts to request library service area data be added to the real estate Multiple Listing Service, and summarized their discussion of alternate funding resources for libraries that want to or are participating in the expanded Cards for Kids Act. The committee discussed big-picture goals for upcoming discussion, and added security

and centralized cataloging collaboration to the list. Stagg extended a thank you to Deirdre Brennan for her leadership, as it was Brennan's last Consortia Committee meeting.
