
- 3.1. Announcements of new committee and ex officio members

## 7. Reports

## 7.1. RAILS Report – Monica Harris

Harris highlighted from the report some of the work that the RAILS staff Climate Team have been working on with the direction of EDI consultant Biz Lindsay-Ryan. The team continues to work on issues of RAILS internal culture with a focus on equity, diversity, and inclusion for all RAILS staff. Harris encouraged the committee to review the list of continuing education opportunities within the report.

## 7.2. BIPOC Library Workers Networking Group

Mistalski reported that at the last meeting of the BIPOC Library Workers Networking Group they discussed the upcoming ILA and YALSA conferences, how various libraries conduct staff evaluations, and also pay equity. Also discussed at the networking meeting were resources for professional development and presenter recommendations.

Bowling Dixon shared that she will be a panelist at the upcoming ILA conference in October at a session that will talk about negotiating salary.

### 7.3. IACRL DEI Committee

Chavez reported that the DEI Committee recently had their first meeting of the year. The committee follows the ILA DEI toolkit in their work.

## 7.4. ILA Diversity Committee

Jenkins talked about several upcoming and past events from the ILA Diversity Committee. At the 2023 ILA Annual Conference the group will host the DiversiTEA session with guest speaker Stephan Jackson, Director of Equity and Anti-Racism at Oak Park Public Library. The Diversity Committee will expand the ILA Mentorship Program. The mentorship program gives the newer librarians a chance to learn from those who have been in the field longer. Jenkins talked about the private DiversiTEA Facebook Group that was established for marginalized groups.

# 8. Committee Sharing of EDI Initiatives

Hollister invited the committee members to come to the meetings with stories to share of EDI initiatives that either they have heard of or that has worked in their own library. This agenda item will be a reoccurring topic of discussion on all upcoming meetings.


### 9. New Business

## 9.1. Review of Committee Charge

The Freedom Lifted Learning Lab offers Justice at Work, a self-paced asynchronous course with a focus on social justice in libraries.
