As part of RAILS' ongoing commitment to equity, diversity, and inclusion (EDI) we are offering a new online course to RAILS members: <u>Social Justice in Public Libraries from Freedom Lifted</u>. inclusion to real, honest conversations about justice." This asynchronous course is a flexible learning opportunity that is suited for individual learners or a group learning environment.

RAILS again invites member networking groups, consortia, and libraries to apply for a <u>RAILS</u> <u>Continuing Education Event Grant</u>. This grant supports CE events for RAILS member libraries towards the development of library staff and trustees. To qualify, CE events must be made available to all RAILS member library staff. **RAILS continues to prioritize events focused on equity, diversity, inclusion, and accessibility**, but will consider applications for all other CE topics of broad interest. The maximum grant award is \$2,000.
