Executive Director Report, March 2024

Provides leadership in ensuring sustainable, equitable resource sharing

Visit to the Evanston Public Library

Thank you to Evanston Public Library Executive Director and RAILS Board Member Yolande Wilburn for the opportunity to tour the Main Library and to hear more about her exciting plans for Evanston.

Illinois Legislative Updates

I attended the most recent Illinois Library Association's Public Policy Committee meeting on March 4th. Lobbyist Derek Blaida highlighted important deadlines for the state legislature, noting the expectation that there will not be much movement through the March 19th primary and that things will pick up significantly after the Easter holiday.

Blaida also highlighted additional bills for the committee that ILA is watching closely:

- <u>HB4224</u>: Seeks parity between libraries and other governmental units to require library treasurers to hold a bond of 10% of total revenue collection (as opposed to the current level of 50%). Has been assigned to revenue – property tax subcommittee and has three co-sponsors.
- <u>HB4258</u>: Amends the License to Read Act to include provisions regulating contracts between libraries and publishers, including the provision that no contract will restrict libraries from operational functions, restrict disclosure of the terms of its license to other libraries, or enable violation of the Library Records Confidentiality Act. This bill has been referred to the State Government Administration Committee and has two co-sponsors.
- <u>HB4567</u>: Amends the criminal code to include library employees as protected in relation to threats and disorderly conduct. Has been referred to Judiciary Criminal Committee and has ten co-sponsors. This bill was sponsored by Secretary of State Alexi Giannoulias as an additional support for libraries facing threats and other conduct challenges.
- <u>SB173</u>: Amends Right to Privacy in the Workplace Act. Provides an employer who engages in electronic monitoring to give notice to employees. Has been Re-assigned to Judiciary. One amendment has been proposed.
- <u>SB2787</u>: Amends the Illinois Local Library Act and the Public Library District Act of 1991. Requires competitive bidding for contracts in excess of \$35,000 (rather than \$25,000) for specified improvements and equipment purchases. Was postponed after being assigned to Local Government. This bill has three co-sponsors.
- <u>HB2401</u>: Reintroduced from last legislative session. Amends the school code and requires that books included in any course include diverse authors. Includes school board level control of reading material. Has been assigned to the elementary and Secondary Education School Curriculum and Policies committee. Two amendments have been proposed to this bill.

ILA has published a list of the bills they are <u>monitoring</u> if you have an interest in following these changes. RAILS Associate Executive Director Joe Filapek will attend a meeting on March 26 with ILA PPC and Blaida to go through the current bill list in more detail.

FY2025 System Area and Per Capita Grant

We received instructions from the Illinois State Library for the FY2025 System Area and Per Capita Grant application. The Secretary of State's budget request for FY2025 would fund RAILS operations and services at an estimated \$11,870,000. We are at work on creating our FY2025 budget and operational plan and will share a draft of the operational plan with the Board at the April meeting.

Delivery Count Conversations with Consortia Committee

We have begun early discussions with our Consortia committee about the possibilities around the reports they can generate from their various Integrated Library System (ILS) and whether we can feasibly explore the option of reporting that could take the place of the Delivery Count. This is a complex process as each ILS has different reporting structures, not all material that moves through delivery is accounted for by reporting, etc. Anne Slaughter, Mark Hatch, Joe Filapek, Grant Halter, and myself are beginning to work together on the RAILS side to create a detailed list of all types of material that moves through Delivery and then determine the general frequency of each type. We've received some sample reports from RAILS LLSAPs and we hope to continue the discussion at the next Consortia meeting in April.

RAILS Minute

In March, the RAILS Minute highlighted the SLATE Data Dashboard launch, Freedom Lifted and the accompanying survey for member feedback, and an Illinois legislative update. The RAILS Minute is available in video and audio podcast format. Thanks to Digital Marketing and Communications Specialist Ola Gronski and Marketing and Communications Director Dan Bostrom for all their continued work on this offering.

Models best practices in equity, diversity, accessibility, and inclusion

Climate Team

The RAILS internal Climate Team is a group of staff across departments focused on ways to make RAILS a more equitable, diverse, and inclusive organization. The group has focused on several topics as of late including staff training models, onboarding, and the hiring process. They have established the need for the development of a video that can shared with new staff during onboarding the focuses on RAILS ongoing commitment to and values around EDI. We hope to have the video developed and ready to share in FY2025.

EDI Training for RAILS Staff

RAILS is offering two opportunities for all staff to continue their EDI learning with a two-hour training session led by RAILS' EDI Consultant, Elisabeth 'Biz' Lindsay-Ryan. These sessions, to be held on May 9 and May 16, will offer a review of previous training led by Biz and take them through the next step of considering what actions they need to take in their roles at RAILS. In addition, all RAILS supervisors will take part in managerial training led by Biz that will help them consider their role as leaders and what part they play in operationalizing EDI at RAILS.

EDI Training for RAILS Member Library Trustees

RAILS' EDI Consultant, Elisabeth 'Biz' Lindsay-Ryan, will present a three-hour workshop for RAILS member library trustees on April 26 from 9 a.m. – 12 p.m. This session will include a general overview of current trends and research about handling diversity topics, particularly race, gender, ability, and family structure, and how library board members' perspectives may impact their communities.

Assist member libraries in preparing for the future

Support for School Libraries on Public Act 103-0100

As we have discussed, <u>Public Act 103-0100</u> became effective on January 1. We are increasingly hearing from school member libraries with questions about how they can be compliant with the new law. We discussed potential avenues for information sharing with the Partnership (AISLE, ILA, IHLS) and are currently in the process of collecting Frequently Asked Questions about the law so that we can create documentation that will be shared by our organizations. Hopefully more on this next month.

RSA Independence Project

RSA Executive Director Kendal Orrison and the RSA team are continuing to move forward on their progress towards independence. The <u>RSA Independence Project</u> webpage was updated with a great deal of documentation for RSA members on March 1. Included is a memo about RAILS Support of RSA and the RSA Independence Project and a breakdown of the differences between RAILS and RSA to help members understand the history of the project and their services moving forward.

Leads alongside member libraries to develop and strengthen Illinois library community

Statement of Economic Interests

If you served on the RAILS Board in 2023, you should have received your invitation to complete a Statement of Economic Interests from Cook County. If you have not received one, please let Emily Fister know asap. After you complete the process, please forward your confirmation email from Cook County to Emily. RAILS must submit copies to the Illinois State Library with our SAPC grant application.

Joint Board meeting with Illinois Heartland Library System Postponed

After a great deal of discussion and planning between our teams, the IHLS Board is unable to commit to the April 30 date in Bloomington. We will be meeting again on March 19 to discuss potential fall dates to meet in Bloomington. Thank you all for your prompt responses on this matter, and we look forward to having more details to share about new dates soon.

Meetings with the Illinois State Library

I continue to meet regularly with the Greg McCormick, Director of the Illinois State Library. We discussed an innovative approach to serving an unserved area between Rosemont and Des Plaines. The Illinois State Library is actively in the process of hiring for open positions. We also discussed the possibility of federal funds for library capital projects available via congressional representatives. Greg McCormick also noted that the opportunity for an official ISLAC appointment for RAILS may be coming soon.

Transition to New RAILS Rockford Delivery Hub

The transition to our new Rockford delivery hub will take place on Monday, March 25, with routes beginning the day at our current facility at 4607 Colt Road in Rockford and returning to our new facility at 4717 Colt Road. Staff are currently working through a 44-point relocation checklist to ensure a smooth transition. In addition to its close proximity to our existing space, this new facility will offer several advantages including indoor parking for RAILS vehicles, increased square footage, and newer HVAC equipment. In the weeks ahead RAILS will coordinate a few necessary upgrades to this new facility including the installation of security cameras and alarm system, enhanced interior and exterior lighting, and upgraded data ports.

Deals & Discounts Webinars/Demos

RAILS hosted a webinar on February 22 for a reading program management resource. The webinar drew 6 registrants who were engaged with questions about the features, rewards, and ILS integration. The webinar recording is posted on the RAILS Deals & Discounts page.

ConsortiaManager & Data Management

RAILS Director of Library Resources and Programs Leila Heath and Jenny Taylor, Associate Director of E-Resources at CARLI, met on February 20 to discuss issues and procedures pertaining to consortial group purchasing.

Anna Behm, Leila Heath, Karen Goyer and Jody Rubel met with Wayne Dixon, Grant Halter, Janette Derucki, and Brian Smith to strengthen L2 data points procedures. The L2 data points are a critical part of the group purchasing renewal and join processes.

Anna Behm, Leila Heath, and Jody Rubel met with Barb Millier to discuss the eRead Illinois fee change project and how it might relate to Find More Illinois's fee structure.

The eRead Illinois join/renewal dashboard went live on February 12. Member testing of the dashboard and renewal forms began on February 15 for select libraries. This testing allowed RAILS to identify and correct any issues or bugs before the renewal period begins on March 18. Jody Rubel met with finance staff Kim Perry and Deb Mitchener to give an overview of the new eRead Illinois dashboard.

Career Online High School Update

Career Online High School is an 18-credit, vocation-based high school completion program.

Jessica Barnes and Leila Heath sent invitations to all participating Career Online High School libraries to go over pricing changes starting July 1 and to discuss future plans for the program at their libraries. They met with Kristen Newcomb from Berwyn Public Library on February 8 and Zach Terrill from McHenry Public Library on February 22.

In February, RAILS secured a discount for Gale: Excel Adult High School for member libraries. Details can be found on the RAILS Deals and Discounts webpage. Libraries have the option of participating in Career Online High School, Gale: Excel Adult High School, or both programs concurrently. Currently, three Illinois libraries use Gale Excel Adult High School (one library runs both programs concurrently).

Update on RSA Independence Project

RSA has finalized all its Independence Documentation, the new Intergovernmental Agreement (IGA), Bylaws, and Fee Structure for FY29, as well as the fee structure phase-in period. All that paperwork has been sent to

the membership. Now members review and sign the IGA to remain in RSA after 1 July 2024. This is the culmination of about 5 years or work.

Find More Illinois Update

Find More Illinois is moving forward with onboarding the many libraries that joined in the last weeks of December. Over thirty libraries joined FMI in the final weeks of the incentive program where RAILS waived the one-time set up fees for FMI

participants. We are working toward testing connectivity with Cooperative Computer Service (CCS) libraries, and Farmington Area Library District and Lake Park High School District #108 are preparing for training.

eRead Illinois Update

Anna Behm, Leila Heath, Monica Harris, and Joe Filapek met with Quinn McKissock and Grant Halter to discuss the eRead Illinois data project. They discussed the current status of the project as well as potential outcomes and applications.

RAILS reached out to RSA about renewing their consortium-wide participation in eRead Illinois. We are working with them to coordinate their renewal as they navigate the RSA independence project.

Anna Behm continues to work with the team at Baker & Taylor to discuss ordering maximizing ordering efficiencies for the eRead Illinois collection.

New Steering Committee for Statewide Mentoring Program

Following a survey that indicated significant interest, a steering committee of staff from member libraries was formed, and the group had its first meeting on March 11. The program is anticipated to formally roll out to interested mentors and mentees around the Illinois Library Association's annual conference in October.

Kate Niehoff is joining other statewide continuing education providers at monthly COSLA (Chief Officers of State Library Agencies) Continuing Education networking meetings.

March Meeting with AISLE, CPS, IHLS, ILA, and ISL

RAILS has monthly meetings with representatives from the Association of Illinois School Library Educators (AISLE), Chicago Public Schools (CPS), Illinois Heartland Library System (IHLS), Illinois Library Association (ILA), and the Illinois State Library (ISL) to discuss ways we can work collaboratively to support school libraries.

RAILS Participates in 2024 PrairieCat Resource Sharing Summit

RAILS Associate Executive Director Joe Filapek co-presented with Illinois State Library Director Greg McCormick during the PrairieCat Resource Sharing Summit held on March 7, 2024 at the DeKalb Public Library. The focus of this resource sharing summit was on the unserved, and approximately 45 staff from PrairieCat libraries attended this full-day event. The presentation from RAILS and the Illinois State Library focused on topics including non-resident cards, reciprocal borrowing, intergovernmental agreements, the Cards for Kids Act, as well as a lengthy question and answer session with participants.

Joe Filapek Presents Training for Lisle Library District Board of Trustees

RAILS Associate Executive Director Joe Filapek presented a training to the Lisle Library District Board of Trustees during their March 20th board meeting. Titled *Advocates & Allies: Trustee Leadership for Today's Public Library*, this training explored topics including trustee roles, board vs. director responsibilities, and the importance of establishing a trustee onboarding process.

Burr Ridge Network Cabling Project Completed

The replacement of all network cabling, some of which was 25 years old, at the Burr Ridge location was successfully completed. This project also involved replacing aging switches and adding secure cabinets rather than racks for the switches, and improved the physical integrity and security of our network, created easier access for future upgrades, and allows compatible devices to access the network at higher speeds.

New Monitors and Stands for RAILS Staff


