# RAILS Releases Illinois Libraries: Agencies of Impact, a Data Study

At RAILS, our mission statement "We Connect Libraries" reflects our belief in the transformative power of libraries. We go beyond brick-and-mortar walls, fostering collaboration and resource-sharing to empower libraries of all types and sizes. That's why we have published the *Illinois Libraries: Agencies of Impact, a Data Study*. We want to help member libraries of all types and sizes demonstrate their value to their various stakeholders. This booklet is designed to assist you in doing just that by diving deep into the quantifiable impact of Illinois libraries. #### CTL Contract Renewal

Over the past few months, RAILS staff have evaluated several different contract renewal options from our delivery contractor Continental Transportation (CTL). CTL currently provides delivery and sorting services for RAILS to support interlibrary loan for member libraries primarily located within Cook, DuPage, and Lake counties. After completing a thorough budgetary and staffing analysis for these renewal options, RAILS staff determined that the most advantageous option is to retain delivery services with CTL while reassigning sorting responsibilities for these routes to our Bolingbrook operation. Although this revised CTL contract represents operational changes not included in our FY25 Plan of Service, we feel that the projected cost savings and opportunity for increased efficiencies merit its implementation this year.
