# Provides leadership in ensuring sustainable, equitable resource sharing

#### **RAILS 2024 Year in Review Video**

Instead of doing a RAILS Minute in December, this year we decided to try a <u>video</u> recap of RAILS' work in 2024 for the membership. We highlighted several initiatives that moved forward in 2024, including the SLATE dashboard launch, support for broadband and digital equity efforts, updating our delivery fleet, legislative efforts for Illinois libraries including the Treasurer's bond bill and <u>PA 103-100</u>, efforts to educate libraries on digital accessibility, much more. As always, our Communications Team did a great job encapsulating a great deal of work into an approachable format. I encourage you to take a look at the video if you haven't already. We'll be back to the RAILS Minute in January.

#### **Broadband and Digital Equity Grant Update**

As we await the Illinois Office of Broadband's announcement of the State Digital Equity Capacity Grant program, expected in early February, RAILS has continued to work with our organizational partners, Illinois Heartland Library System (IHLS) and the Consortium of Academic and Research Libraries in Illinois (CARLI) to make progress on outlining a potential grant proposal.

# Models best practices in equity, diversity, accessibility, and inclusion

#### **Climate Team**

The Climate Team recently finished work on a short welcome video for all RAILS staff that outlines our values as an organization. It especially highlights that individuals' name, background, and where they come from shouldn't affect the way that they are treated at RAILS or their ability to succeed here. We plan to show the video at our January staff meeting and then incorporate it into onboarding for all new staff.

#### **EDI Forum**

On January 15 RAILS administered a survey to all former and current RAILS Board EDI Committee members. We are hoping to receive feedback that will help guide the transition of this committee from a board committee to a member-focused committee. It is also our intention to follow this survey with a small focus group of members who can provide additional perspective on how best a future iteration of this EDI committee can best support our membership.

#### Save the Date: RAILS Member Update on February 11

We are looking forward to another RAILS Member Update this February. Topics will include an update of what's new at RAILS, a presentation from Ancel Glink on Meetings Room and First Amendment rights, and more.

#### Leadership Training in RAILS

Thank you again for your thoughtful and insightful conversation on leadership training for Illinois libraries at our November meeting. Your suggestions were very helpful to us as we thought carefully about how to move forward with our planning. Next we will host a series of facilitated conversations with members this Spring in order to design a pilot program of learning experiences for library leaders. We are hopeful that this pilot project will debut in the first half of FY2026. I will certainly share more as this develops.

# Leads alongside member libraries to develop and strengthen Illinois library community

#### Illinois Library Association Legislative Meetups

The annual series of ILA legislative meetups occurred across the state in early December 2024. The ILA's FY2025 legislative priorities discussed included the Libraries Connected proposal (related to providing complimentary internet service to libraries in their role as community anchor institutions; RAILS co-sponsored this proposal) and Considering Equitable Compensation Reporting Requirements (related to the requirement for posting salary information for any employer of an IMRF participating organization for any employee making over \$75k). Also mentioned was the request to fund libraries appropriately, including support for the library systems, and support for the licensed school librarians task force. ILA Lobbyist Derek Blaida discussed potential strategies for moving these efforts forward in the new year.

RAILS staff and Board had representation at all five events in our service area. At the Public Policy Committee meeting in January 2025, it was reported that library attendee levels were back at pre-pandemic levels. Thank you to all of you who attended these meetings, as well as those of you who sent invites to legislators and led the efforts to organize the events in your area.

#### **ILA Public Policy Committee Updates**

The Illinois Library Association's Public Policy Committee met on January 6. ILA Executive Director Cyndi Robinson shared Federal updates, including those related to the Digital Equity Act, as well as upcoming national advocacy efforts in Washington DC: Voices for Libraries (COSLA) in March 2025 and the American Library Association's Fly In Days in April 2025.

ILA Lobbyist Derek Blaida shared Illinois updates, including general discussions dominating the end of the 103<sup>rd</sup> General Assembly. He warned that the budget deficit that is expected for FY26 will likely have a large effect on what will go to committee in the next session. At future Public Policy Committee meetings he will highlight 8-10 bills per meeting that will be of interest to the committee. There was an update from the subcommittee that is compiling relevant legislative changes from other types of Illinois local government, in hopes of identifying potential legislative opportunities for libraries in the future.

#### Voices for Libraries 2025

The Chief Officers of State Library Agencies (COSLA) has announced "Voices for Libraries 2025". This event invites library advocates from every state to travel to Washington DC to talk with legislators about the importance of libraries and to advocate for support. Due to space limitations, state delegations must be limited. Our partner, the Illinois Library Association, has extended an invitation for representation from RAILS and IHLS at the event, which takes place March 5-6 2025. I have registered to attend this event.

#### **ICOLC Update**

The International Coalition of Library Consortia (ICOLC) has announced that its 2025 conference will be held in Chicago, IL on May 4-7. This annual North American meeting is dedicated to keeping participating consortia informed about issues of importance to directors, governing board, and member libraries of consortia. Only consortial staff and members are permitted to attend the meeting and there is no vendor area. I attended an Agenda Planning Group meeting for the conference on January 7 and a Logistics Committee meeting on January 14 and I look forward to future developments.

#### ISLAC

The Illinois State Library Advisory Committee (ISLAC) has cancelled the January meeting. The next meeting is likely to be scheduled for March.

# THE TOP THREE

In response to board member feedback, each month we provide brief talking points to help you spread the word about specific RAILS programs/services. Here are this month's top three:

#### **RAILS #DeliveryWrapped**

Following the style of 2024's #SpotifyWrapped, RAILS highlighted their 2024 delivery stats on social media. Facts included:

- Our delivery drivers made 69,818 stops. That's 468x more than Taylor Swift's Era Tour.
- The libraries that received the most deliveries per type were Highland Community College, McCook Public Library District, United Township High School District #30, and Theosophical Society in America.
- Our delivery drivers traveled 1,111,594 miles. That's the equivalent of traveling to the moon and back 2.3 times.



• Rick and Michael from our East Peoria hub traveled the most miles. This route #6 covers 78,155 miles every year.

#### 2025 Illinois State Library Annual Certification

In compliance with Illinois statutes and administrative rules, annual certification is required of ALL library system members to retain system membership and eligibility for grants administered by the Illinois State Library. Every year, RAILS staff help member libraries complete this required process.

The Illinois State Library Annual Certification form has been streamlined and moved to the Library Directory and Learning Calendar (L2). RAILS offers a step-by-step screencast. The certification period runs from January 2 to March 31, 2025. Libraries that need assistance can contact help@librarylearning.org.

#### Jessica Silva Attends Networking Group Meetings

#### **Project to Update Non-Resident Card Information**

RAILS staff are currently working on a project to update non-resident card information on member public libraries. The board of each public library in RAILS is required to decide annually whether they will participate in the state's non-resident fee program, and to inform RAILS by updating their non-resident information in L2. Since fall of 2024 when we began our outreach to libraries, nearly 150 libraries have provided their updated information to RAILS.

#### Can't Shelve This Episode Three

Episode three, "The Library's Got Rizz," featuring Nichole Folkman from Hartsburg-Emden CUSD #21 premiered on November 12, 2024. Podcast hosts Janette Derucki, RAILS Data Analyst and Leah Gregory, IHLS School Library Membership Coordinator led a discussion about the best way to get students interested in visiting the school library and read listener-submitted programming stories. The episode has gotten 300 podcast downloads and 120 YouTube views.

#### January Renewals Save Libraries Over \$25,000

The Deals & Discounts team completed the January 1 sign-up and renewal processes for Swank Public libraries and BookBrowse. Over 200 libraries participate in these deals and saved over \$25,000. RAILS contacted members through promotion channels, webinars, and individual reach-outs and worked with the vendors throughout the process.

#### 20 People Attend Udemy Webinar

On November 6, 20 registrants attended the "Gale: Learn Something New with Udemy" webinar. This online learning platform provides video-based courses for adults who want to upskill for a new job, advance in their current profession, or deepen personal interests.

#### **Attendees Learn More About Fiero Code**

On December 4, RAILS hosted the Fiero Code: Coding Education for Public Libraries webinar, with 24 registrants and 8 attending the live event. Fiero Code is a fun and interactive coding education platform that includes more than 13 coding languages and devices and can be used for individual learning or in-person coding clubs at the library. The vendor agreed to two free months for new libraries that sign up by 1/31.

RAILS offers two online high school programs for libraries: Career Online High School (implemented Spring 2016) and Gale Excel (implemented Spring 2024). Stats for both programs are listed below:

#### **Update on Bolingbrook Expansion**

As we reported at the September 2024 board meeting, RAILS will be transitioning sorting responsibilities from our outsourced delivery vendor (CTL) to sorting staff at our Bolingbrook service hub. While initially planned for January 2025, the transition has been delayed due to the sale in late 2024 of our Bolingbrook facility. The change of ownership has delayed our ability to occupy the additional suite necessary for sorting as well as the scheduled buildout required for our revised workflow. RAILS staff are currently working with CTL on this transition which we now hope to complete by April 2025.

#### **Work on Delivery App Continues**

The RAILS Delivery app was recently updated. The updates include a link to the facilities checklist, overtime tracking, and additional features that will help support the sorting.

# **Classification Basics Course Reaches Capacity**

The Classification Basics: Understanding Dewey Decimal Classification (DDC) & Using WebDewey course will run from January 27 through February 24. Shortly after the course was announced, registration had reached the cap of 50 participants and five waiting list spots.

#### **Active Shooter Training**

On January 16, RAILS staff will take part in Active Shooter Training with Joseph Crimmins, the Founder and President of Serve and Protect. Crimmins is a retired Police Detective Sergeant with 30 years of experience in criminal investigations and emergency preparedness. With this training, staff can make better decisions in emergency situations, whether it's evacuating or seeking shelter in secure areas, so that everyone can respond appropriately to an imminent danger, enhancing overall safety in our buildings.

# Improvements to L2 Help Documentation

RAILS staff has completed revisions to existing Library Learning (L2) user documentation, created new documents, and planned a roadmap for ongoing documentation creation and maintenance. All documentation will soon be available to RAILS members in an easier-to-access web format, and will support an upcoming promotional campaign encouraging library administrators to review and update their libraries' directory data.

# December & January Partnerships Meeting

#### Welcome Sara Mecurio!

Sara Mercurio joined RAILS on November 19 as a temporary Cataloging Services Assistant (through June 30) funded by the grant from the Illinois STtate Library to increase staff capacity to handle the growing demand for our World Language Cataloging Service. Her capable work has proved to accelerate the pace at which RAILS can complete requests and to expand the time available to ensure effective service administration and grant reporting.

#### **Diana Rusch Presents on ALA LRT Panel**

On December 5, Diana Rusch, as committee member of ALA's Learning Round Table Online Learning Committee, took part in planning and presenting "Training Exploration: Year in Review". The ALA group shared their personal training recommendations from 2024 and took questions from a group of nearly 40 library training staff from across the country.

#### **RAILS CE Team Presenting at Reaching Forward North Conference**

Margae Schmidt and Diana Rusch will be presenting "Discovering Engaging Training Opportunities for Library Staff" at the Reaching Forward North Conference on May 1.

#### **RSA Independence Update**

RSA is in the final stages of planning and starting to move forward with all the tasks required to hire staff. They have contracted with a local HR firm to help us with the many, many steps that need to be completed. RSA intends to be ready to start the process of hiring staff in late March. The biggest step will be getting IMRF approval.

#### **RAILS IT Update**

In November and December, RAILS IT conducted the necessary work on prepare Suite D in the RAILS Bolingbrook Service Center. That includes installing network cabling, internet service, door controls, security and camearas. Also, new network switching hardware has been received for all RAILS service centers. Work will begin soon.

# **RAILS Online Store Update**

After an exciting launch in October, the RAILS Online Store continued to see steady sales during the holiday months. In November, we received 17 sales for 32 items. In December, we received 7 sales for 13 items. So far, the most popular design is "Reading is Reading" in color.




