Executive Director Report, February 2025

Provides leadership in ensuring sustainable, equitable resource sharing

RAILS Funding Update

As many of you are aware, in late January freezes to federal funding were ordered through the Trump Administration's Executive Orders. Several court challenges have been made to these orders, and the ultimate fate of federal funding through many agencies remains unclear. RAILS has received many questions about the impacts of federal funding on RAILS and our library partners. In response to these questions, we have shared relevant information during the February RAILS Minute, the Member Update on February 11, Board committee meetings, and our staff meeting on February 18. The RAILS Communication Team has also developed a new informational campaign, *RAILS: Numbers That Count*, that is intended to address the value that RAILS brings to Illinois through delivery, grants, continuing education, deals & discounts, and much more. We remain in contact with the Illinois State Library about these issues, and we expect to hear more at the March ISLAC meeting about the Illinois State Library budget priorities.

In good news, you will see in the RAILS financial report that this week we received the LSTA (federal) payment for RAILS's Area and Per Capita grant totaling \$1,936,143.79. With the receipt of these funds, RAILS has received the full amount of our FY2025 grant. We want to express our sincere thanks to the Illinois Secretary of State and the Illinois State Library for their efforts and support.

Illinois Legislative Updates

I attended the most recent Illinois Library Association's Public Policy Committee (PPC) meeting on February 3rd. Lobbyist Derek Blaida highlighted important deadlines for the state legislature and Governor Pritzker's address to introduce his proposed budget for fiscal year 2026 on Wednesday, February 19. The Illinois Library Association provided a list of bills that they are watching closely as the legislative season continues. There will be more detail shared at the next PPC meeting on Monday, March 3.

Governor Pritzker presented a proposed budget this week that included no new taxes. The projected deficit that had originally come in around \$3.2 billion was adjusted due to an additional \$1.5 billion in revenue that is expected to come in next fiscal year. There were no new programs introduced that could be costly for Illinois.

In addition to what has been highlighted by ILA, RAILS has learned of several legislative items that we are watching closely, including:

[SB1741](#): Amends the School Code. Requires the State Board of Education to establish and convene the Licensed School Librarian Task Force, which shall meet a minimum of 4 times and submit, no later than 12 months after the first convening of the Task Force, a report to the Governor and the General Assembly containing recommendations, including, but not limited to, recommendations on how to ensure public elementary and secondary schools consider, budget appropriate resources for, and employ licensed school librarians in future school years from available State and local resources.

[SB2124: Let America Read Act](#): Provides that the State Board of Education with oversight over the instructional materials used in public schools shall create a grievance procedure for challenges to instructional materials.

[Illinois Senate Joint Resolution 13](#): Creates the University Library & Professional Librarian Access & Transparency Task Force to examine the current state of libraries and professional librarianship on Illinois public university campuses and present a recommendation to the General Assembly to ensure that public academic libraries and the educational services provided by professional librarian faculty remains a viable and healthy benefit to Illinois students.

[SR0104](#): Urges all public library trustees to participate in ongoing training programs provided by the Illinois Secretary of State to strengthen their ability to effectively oversee library operations and services. Encourages the Illinois Secretary of State to expand and enhance library trustee training opportunities, ensuring that all library board members have access to comprehensive education on governance, ethics, and policy matters.

Related to the last item, Joe Filapek and I met with representatives from IHLS, ILA and Niles-Maine Public Library District on February 10 to discuss the topic of public library trustee training. State Senator Laura Murphy (D – Des Plaines) has expressed interest in exploring legislation focused on trustee training. This preliminary discussion focused on considerations for required trustee training and how the regional library systems and other partner agencies could provide support. Senator Murphy has filed a Senate Resolution urging public library trustees to pursue relevant training opportunities.

RAILS Minute

This month's RAILS Minute focused on an explanation of how RAILS is funded, recent legal questions about immigration enforcement and public library meeting rooms & First Amendment rights, and the World Language Cataloging Services program.

Statement of Economic Interests Form Coming Soon

All RAILS Board members should expect to see something in mid-March from the State of Illinois related to completing your annual Statement of Economic Interest. The Illinois Governmental Ethics Act requires certain employees, state public officials, and appointees to state boards and commissions to file a Statement of Economic Interests form annual on or before May 1.

Models best practices in equity, diversity, accessibility, and inclusion

Digital Accessibility Team Update

The RAILS Digital Accessibility Committee has now met three times since being formed in December 2024. This internal staff committee is charged with establishing and maintaining a comprehensive web accessibility strategy that ensures RAILS' digital content and platforms are inclusive and accessible to all users. The committee is currently working on creating a digital accessibility statement as well as establishing working groups. Brian Smith will also present on this topic to the RAILS Board at our March meeting.

Assist member libraries in preparing for the future

Meeting Room FAQ from Ancel Glink

Recently, RAILS has received questions about public library meeting room policies and the First Amendment. We compiled those questions and had our partners at Ancel Glink produce an [FAQ document](#). This information was also shared at the RAILS Member Update on February 11.

Immigration Enforcement Memo from Ancel Glink

Our partners at Ancel Glink updated the Immigration and Customs Enforcement (ICE) guidance that RAILS originally provided back in 2017 to be relevant to changes in 2025. It is important to note that due to potential changes in the coming months, whether by law or executive order, this guidance may continue to change. Public libraries may want to share this document with your boards as you evaluate the best course of action for your library. It is our recommendation that you also review this with your library's attorney before taking any action.

Leads alongside member libraries to develop and strengthen Illinois library community

Illinois Libraries Present Moving to Illinois Library Association

The Illinois Library Association announced in January that they have acquired Illinois Libraries Present, a high quality online events provider for participating member libraries of all sizes and budgets. In the past, RAILS has provided accounting services to the ILP program. We will be meeting soon with ILA to discuss the transition of these services for the program.

IHLS Member Day Presentation

I had the opportunity to present on the history of the Partnership for School Libraries and the importance of collaboration, along with RAILS Data Analyst Janette Derucki, at the Illinois Heartland Library System's Annual Member Day on February 12. Deep thanks to the IHLS team for having us!

In response to board member feedback, each month we provide brief talking points to help you spread the word about specific RAILS programs/services. Here are this month's top three:

RAILS Moves Forward with Broadband & Digital Equity Plans

Following the release of the Notice of Funding Opportunity for the DCEO Office of Broadband's State Digital Equity Capacity Grant, RAILS is taking the lead on a grant application in collaboration with IHLS and CARLI. If funded, the project would support capacity-building efforts for technology and digital inclusion services in under-resourced public libraries across Illinois.

Chicago Tribune Digital & E-Edition Pilot Project

RAILS Deals & Discounts secured a deal to bring *Chicago Tribune* Digital and E-Edition access to RAILS member libraries at a discounted price. RAILS is partnering with *Chicago Tribune* parent company MediaNews Group to provide an initial pilot program from March – June 2025. The pilot will include a small subset of RAILS members prior to the general rollout for this offering who were selected to include representation for each LLSAP within RAILS and a variety of sizes, regions, catalog, and authentication methods. The goal of the pilot program is to test and collect feedback in preparation for a larger-scale rollout later this year. There has been strong positive interest in this initiative so far, and the Deals & Discount team is excited to bring this opportunity to RAILS members.

Planning Begins for Inaugural RAILS Data Conference

Planning for the inaugural RAILS Data Conference has begun! The RAILS Data Team is collaborating with eight data-minded library professionals from across the state to plan a one-day learning and networking event taking place on Monday, October 13, 2025 in Rosemont, Illinois.

Recent CE Events

- **“Science of Reading”**, webinar, January 28
Dr. Joanna Christodoulou, developmental cognitive neuroscientist and educator, reviewed the framework termed “Science of Reading” as it relates to reading development and difficulties in school-age children.

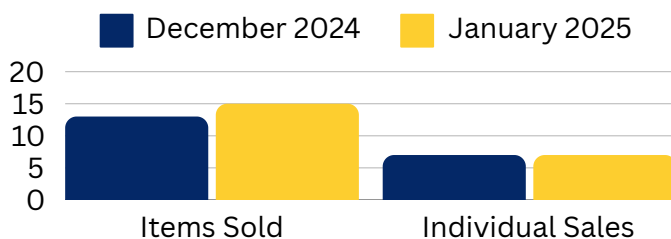

Consortial Reports

January 27, 2025

Consortium of Academic and Research Libraries in Illinois (CARLI)

CARLI celebrates its 20th anniversary in 2025.

I-Share

CARLI is working on its renewal with Clarivate/Ex Libris for Alma and Primo VE.

CARLI will share information with non-I-Share members about the opportunity to join I-Share with a go live date in 2026.

Continuing Education

CARLI is working on an agreement with the Association of College and Research Libraries (ACRL) to host the ACRL Roadshow: Assessment in Action, on June 5, 2025. The event will be held at Illinois State University.

Cooperative Computer Services (CCS)

Staffing

Molly Mansfield started on December 9 as CCS's new Member Services Associate. Molly brings a wealth of experience from a diverse background in academic, public, and library vendor settings. This includes years of expertise in delivering both in-person and virtual training sessions for libraries and their users at organizations such as Dominican University and LibraryIQ. In her new role, she will collaborate closely with the Member Services team to offer support and training to all our members.

Polaris 7.7 Upgrade

The training database was upgraded to 7.7 on December 11. CCS staff started QA on the training database and Member Services staff are evaluating related training and documentation needs. We anticipate upgrading to 7.7 in February.

Once our production upgrade is scheduled, development will implement a "hypercare" situation. A development team member will be assigned to watch our servers for the first days we are on the new version to monitor for any potential system issues. Development will have specific time set aside for this monitoring and any needed troubleshooting or patch development.

Discovery Interface Comparison Project

Our user experience testing of discovery layers is the second of multiple phases that will lead us to Governing Board selecting a discovery layer in May 2025.

- Phase One: User Experience Testing
- *Phase Two: Scoring and Data Synthesis*
- Phase Three: Vendor Demos/Presentation
- Phase Four: Governing Board Decision
- Phase Five: Negotiation and Implementation

The report will be available within the month.

Find More Illinois- Northbrook and Highland Park

CCS and RAILS are working with Highland Park and Northbrook to prepare for their January 27 launch. K. Lyons has completed training sessions and is finalizing SHAREit settings for both libraries.

Strategic Planning

- After February’s Governing Board business meeting, we will conduct a strategic planning retreat. The focus will be on service design, further exploring member interest and expectations around the top priorities identified in the survey.
- Governing Board will review and approve the new strategic plan at the May 2025 meeting.

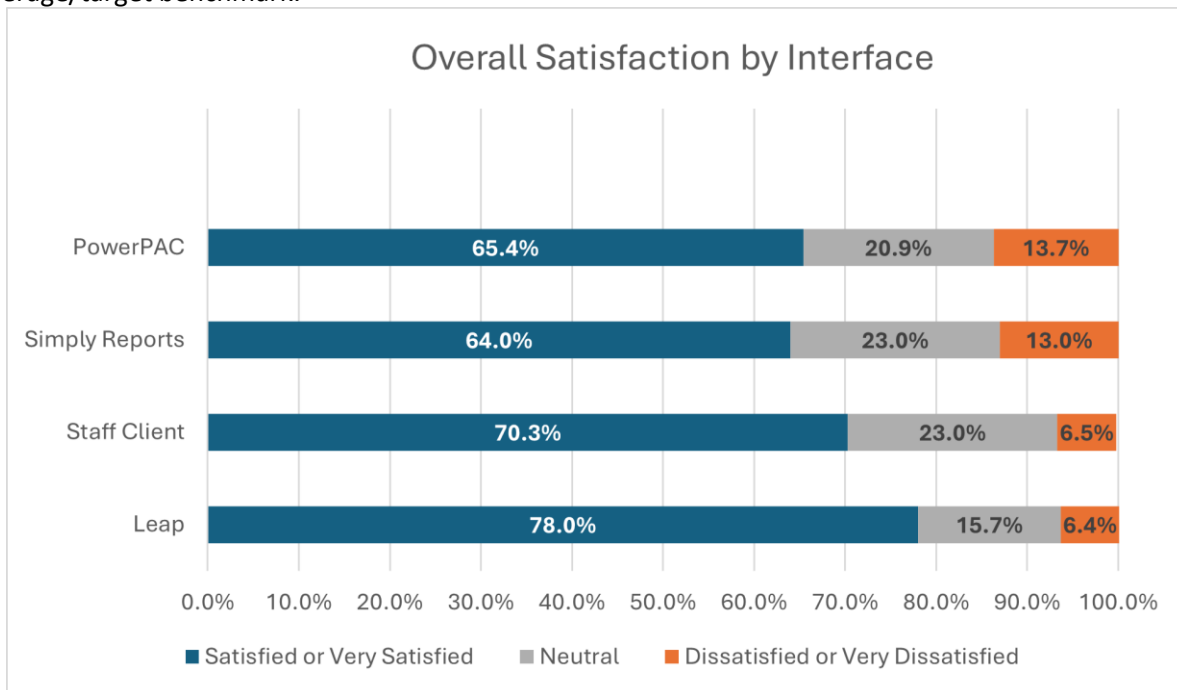
Polaris Satisfaction Survey

Over 300 library staff completed our Polaris satisfaction survey--thank you! The survey asked members to share their satisfaction and feedback on each Polaris interface:

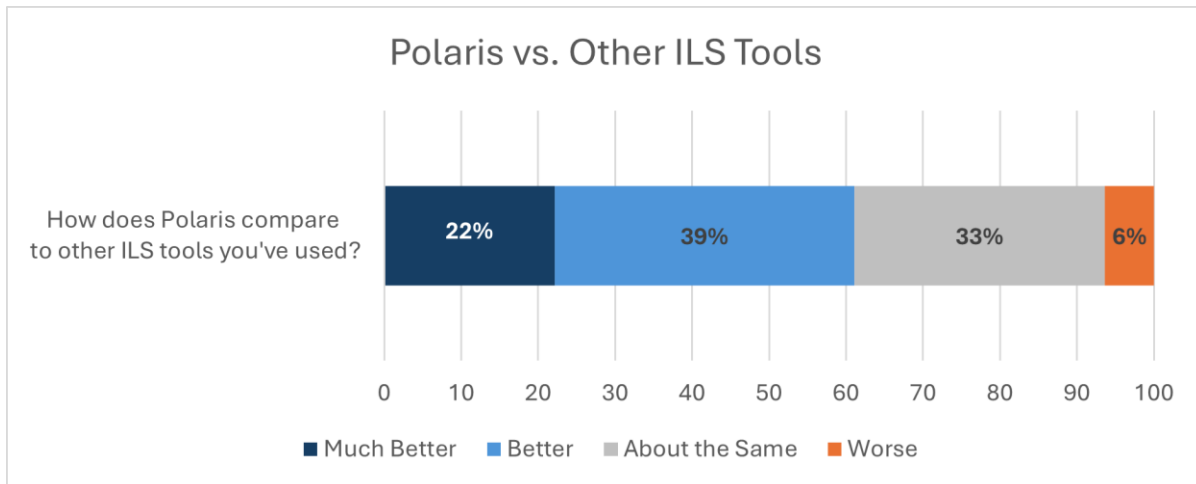

Survey respondents showed the highest satisfaction with Leap, with 78% of respondents being satisfied or very satisfied with that tool. The ACSI (American Customer Satisfaction Index) customer satisfaction benchmark rating for computer software is 78, putting satisfaction with Leap on par with the industry average/target benchmark.



221 respondents reported using another ILS at some point in their careers and, of those users, 94% said that Polaris was on par with or better than the other tool(s) they've used.



CCS will use the data collected in this survey, as well as staff experience, tickets, and other data sources to help determine priorities for our upcoming contract renewal. The full report is available to member library staff at on our [website \(login required\)](#).

Pinnacle Library Cooperative

New Staff Training Platform- Coassemble

Pinnacle staff are in the process of moving our ILS training content to our new learning platform from Coassemble. Like many of the platforms available, Coassemble focuses on using interactive micro-learning in short, easily digestible segments. We plan to launch the platform in the Spring, replacing our existing training options.

Once on Coassemble, staff will be able to create their own accounts to track progress and share completion with their supervisors. Libraries will also have the option to create library-specific or department-specific content and assign it to specific staff.

Census Geographic Data

As part of our NCOA cleanup last year, Unique Management provided us with geographic data for most of the patrons in our database. Combining that information with publicly available census data, we created an interactive tool in Google Data Studio which maps library patrons by Census Tract and Block Group. Available maps include registered patrons by Block Group, checkouts by transacting branch, checkouts by patron age/item type, and reciprocal borrowers visiting Pinnacle libraries.

Polaris 7.7

On January 26, we will be upgrading to the newest version of Polaris. The new version includes additional functionality for the web-based components, including a split-screen MARC editor and the early stages of System Administration settings. Polaris' native self-check software is also getting a much needed overhaul, which should give libraries the option to deploy self-checks on their own equipment without the need for expensive maintenance contracts.

LX Starter

Pinnacle staff are in the process of testing LX Starter - Innovative's replacement product for email notices. We've successfully connected it to the ILS and have sent test notices. Once we complete testing

the functionality, we'll begin onboarding member libraries who are still using the standard ILS notices. We hope to launch this Spring.

PrairieCat

PrairieCat has been busy over the last few months. Below is a summary of some of the work we are doing:

- We are finished with vendor demonstrations and are currently evaluating our options for a mobile app, as our contract with Capira/OCLC expires in October of this year. We have had vendor demonstrations from Innovative, Capira/OCLC, Bibliocommons, and Communico. Our UX committee will shortly be making a recommendation for the Administrative Council and Delegates Assembly to consider.
- Our strategic planning process continues. We have performed surveys of our general membership as well as more targeted surveys of our committees and will shortly be writing a new activity plan for the coming 3 years.
- Our previously mentioned website Forums will be launching soon. We envision this as a member to member sharing tool for topics related to library services. The hope is that this will foster less reliance on listservs and email and promote more member engagement.
- We recently implemented the Vega Guide, a help tour enabled on all our Vega Discover sites.
- We recently published new online courses on Showcase creation for Vega Discovery and are implementing "online office hours" for Showcase support.
- We have completed beta testing of Vega user roles and permissions / homepage builder, and plan to launch this to membership in early Spring.
- We continue to promote the PrairieCat Passport program. The program, held on quarterly FY25 Delegates Assembly meetings, encourages visits to member libraries in the area.
- We recently completed a website accessibility audit performed by our website hosting service, Cherry Hill. We are currently working on rectifying issues found in the audit. In general, our website is in good shape regarding accessibility.
- Our systems staff are excited about having moved to using Microsoft Intune for pc deployment. PrairieCat has shifted to a mostly work from home environment, which brings about its own unique challenges. One of those challenges is managing our laptops. To solve this, we utilize Microsoft Intune. This solution allows us to unify our remote machines without having them in one location. This is an imageless solution, so in addition to remote management, there is no storage overhead or image maintenance. Intune allows us to install software, manage updates, assign policies, and more. Once Intune is configured, setting up a laptop in our environment is as easy as enrolling the device to Intune, and signing into a Microsoft Entra account. Intune has allowed PrairieCat to thrive while navigating a changing workplace landscape.
- We have another library adding Smiota automatic pickup lockers to their new branch. This will be our first multi-site Smiota installation. We currently have four libraries using Smiota pickup lockers and one using Demco lockers.
- Database Maintenance and Cleanup: We are actively addressing the outcomes of previous system migrations by merging duplicate records, updating incomplete catalog entries with more comprehensive data, and enhancing minimal-level records in OCLC Connexion prior to their export to Sierra.

- Batch Record Uploads: We are facilitating the batch uploading of records from OCLC Connexion to Sierra, ensuring a streamlined process and accurate data integration.
- Vega Discovery Support: We are working diligently to resolve display issues within the Vega Discovery system to improve user experience and functionality.
- Training and Support: We are delivering training and monitoring courses through the Talent LMS platform to ensure continuous professional development and effective system usage.
- Original Cataloging: We provide original cataloging services to our members, ensuring accurate and comprehensive bibliographic records.
- Vendor Evaluation: We are actively exploring new vendors to replace MARCive, with the goal of enhancing service offerings and system compatibility.
- Collaboration with CMC: We are collaborating with CMC on various cleanup projects, including local history and local author original cataloging, to ensure accurate and complete collections.

Rock River Library Consortium (RRLC)

No report is available at this time.

Resource Sharing Alliance (RSA)

Administratively, almost all our time is being spent on the process of directly hiring staff. We've contracted with an outside HR firm to help us work through the process of everything that needs to be done. There appears to be an endless supply of new things cropping up.

In addition, we're rewriting a staff handbook, policies, procedures, etc. required to have direct employees. And we're working through our job descriptions and added two new levels of positions in each department so that each has three levels of positions. That will allow us to hire staff with less skills and also have a viable place to promote employees in the future. We also need to create an office manager type position to do all the new tasks that come with employing people. Our target is to begin a hiring process in last March.

We continue to visit each of our members to do a Parameters Party. We've done all our public libraries, and we'll spend the next several months touching all the school, special, and academic members. This process typically results in 10 to 20 cases per visit and requires a lot of staff time. On the upside, we're able to setup the system to better work for our Members.

The Cataloging Department has also started visiting libraries in person to help members with whatever is going on in their library. We hear many more things in person than on a Zoom or phone call. Our new, shortened, 1-day Basic Cataloging Workshop has been a huge hit with full classes since implementing the update from the old 3-day workshop. Two of our Catalogers, Jennifer Choate and Erin Roberts, are working as cataloging mentors for iCamp which they report to be very interesting. That program runs through this summer.

RSA made 63 member visits in the last quarter of the year. The majority of those were in library visits as we've found those to be the most effective. We asked our members if they would like to host in person training events in their library and we were inundated with volunteers.

System Wide Automated Network (SWAN)

Headquarters move

SWAN signed a new seven-year lease for a small office located in Oak Brook and moved in December. We no longer utilize RAILS Delivery at the new location. The new address is 915 Harger Road, Suite 260, Oak Brook, Illinois 60523.

Payments to SWAN will continue with the P.O. Box 6286 Carol Stream, IL 60197-6286 which deposits automatically with our bank.

International Coalition of Library Consortia annual conference of the Americas May 4-7, 2025

The annual ICOLC meeting will be held in Chicago from May 4th through May 7th. CARLI, IHLS, RAILS, SWAN and other groups have volunteered to help with conference planning. The conference registration fee and location have not been announced yet, but signing up for ICOLC is free which will allow library consortia staff to join the ICOLC email list.

New ticketing platform go-live

SWAN selected HaloITSM as our next ticketing system. Training with SWAN staff is currently underway, with membership training sessions listed in L2. We are expecting to go-live with our member libraries on March 3, 2025.
