SUBJECT: Community College Survey Results (Updated)

In January 2019, RAILS asked community college libraries in RAILS to complete a survey about services to their district residents and, more specifically, services to persons without public library service. As discussed at the September 20, 2019 meeting of the Resource Sharing Committee, this survey was a follow-up to a more general community college library survey done in November/December 2017.

As of March 5, 2019, RAILS had received 21 of 32 possible responses, for a 65.6% response rate. The attached table and summary are based on these 21 responses. RAILS staff have followed up with the libraries that have not yet responded.

Summary

- Twelve of the twenty-one libraries responding (57.1%) allow community borrowers to borrow materials. Some libraries limit borrowing privileges to district residents, while others extend privileges to anyone with a public library card. Of the nine libraries that don't offer cards to community borrowers, five are in Chicago, where all residents have access to the Chicago Public Library.
- Fourteen of the twenty-one libraries (66.7%) provide cards to persons without public library service. Of the seven libraries that reported they do not, five are in Chicago and thus have no district residents without public library service.
- Only one library charges for library cards, and that fee was nominal (\$5.00 for two years).
- Most libraries do not promote services to community borrowers. The information is often posted on the library website, and those who ask are told about the services. Four of the libraries do some form of outreach to public libraries in their district.
