6.4. Resource Sharing Committee Report

The Resource Sharing Committee meeting on April 28, 2025, will include a report on Find More Illinois and an overview of RAILS' e-content. Harris reported that the transfer of sorting responsibilities from CTL to the RAILS Bolingbrook hub was completed in March. In this transition, RAILS continues to evaluate and modify workflows as the workload on Bolingbrook staff increases.

7. Unfinished Business

7.1. Update on broadband expansion in Illinois

Slaughter announced that RAILS has applied for the Illinois Digital Equity Capacity Grant in partnership with IHLS and CARLI. The project aims to build capacity for rural and under-resourced libraries to provide digital services to their patrons. Funding for the grant will be sub-granted out from the federal Digital Equity Act funding. Slaughter noted that even if federal funding is delayed or reallocated, elements of the grant application can be applied to many other areas. Slaughter noted that, in early summer, the Illinois Office of Broadband plans to release a NOFO for lead organizations to work with regional teams and help establish centralized points for regional broadband expansion and technology adoption.

7.2. Update on Illinois State Library Advisory Committee and FY2026 budgeting

Harris attended the Illinois State Library Advisory Committee (ISLAC) meeting in March where Anne Slaughter and Troy Brown (IHLS) gave a presentation about broadband equity access and deployment; the Illinois State Library provided an overview of the OCLC WorldCat Discovery Subscription as it relates to IMLS funding; and the committee discussed a breakdown of per capita grant funding. Any changes in IMLS funding should not affect per capita grants to public or school libraries. Harris reported that the Illinois State Library has recommended that RAILS submit a level budget for FY2026.
