6. New Business

6.1. Library Association Challenges and Support

Mary Davis Fournier, Public Library Association (PLA) Executive Director, spoke on the topic of library association challenges and support. Challenges include providing a unified voice while advocating for the nation's libraries and adapting to changing technology. Attracting and retaining members is an important issue for library associations. Individual membership to the Public Library Association provides access to continuing education, resources, and opportunities for professional development that institutional membership does not allow. Members are an important source of information for the library association to ensure its work aligns with issues libraries are facing. Libraries can support the library associations by encouraging staff to join with an individual membership. The public may join PLA as a full member or a public supporter.

7. Reports

7.1. Institute of Museum and Library Services Update

Harris provided updates on the Institute of Museum and Library Services (IMLS), including the termination of the digital equity capacity grant, a positive ruling on E-rate funding, the Fifth Circuit Court of Appeals ruling that politicians have the right to remove books from public libraries, and ongoing legal challenges to IMLS staffing and funding. The decision on the renewal of IMLS is due in September.

7.2. Illinois Legislative and Advocacy Update

Harris reported on the status of bills related to broadband access, non-resident fees, opioid antagonist availability, and expanded security grants.

7.3. AISLE Advocacy Committee Report

There was no report.

7.4. ALA Annual Reports on Legislation and Intellectual Freedom Overview

Harris reviewed ALA's annual reports on legislation and intellectual freedom, noting a significant increase in book challenges and the rewriting of the Library Bill of Rights.
