Executive Director Report, August 2025

Provides leadership in ensuring sustainable, equitable resource sharing

Institute of Museum and Library Services (IMLS) and Other Federal Updates

Changes and developments about Federal support for libraries have continued since we last met in July. As this situation continues to change, I encourage you to visit the RAILS <u>IMLS Advocacy</u> Pulse page for the most up to date information we have to share.

On July 30, a federal judge <u>declined to reinstate</u> Register of Copyrights Shira Perlmutter (who was fired on May 10) saying that she failed to show "irreparable harm". She has since filed an <u>emergency motion</u> to keep her position.

A book banning case in Iowa has national interest where book banning provisions included in <u>lowa Senate File 496</u> are being challenged in a new <u>legal brief</u> by a coalition of publishers and authors. The coalition is encouraging the court to uphold a lower court ruling that found the provision unconstitutional. The law was originally blocked by the Eighth Circuit court and has been appealed by the state and is now before the Eighth Circuit Court of Appeals.

On July 27, a New York federal court <u>blocked</u> the government's termination of 1400 NEH research grants to scholars and authors.

On July 31, a bipartisan group of US Senators <u>rejected cuts</u> to education and libraries including the recommendation of nearly full funding for IMLS and the Department of Education. It would still need support from 60 Senators in the full Senate to pass and the House version, which isn't due until September, could look very different. If eventually approved by both chambers, the budget would take effect on October 1.

Illinois Legislative Updates

I attended the August Public Policy Committee meeting as Ex Officio. ILA confirmed that they have received several legislative proposals that will be discussed by the committee at an in person meeting in Bloomington on August 25. Derek Blaida shared that a deficit is expected for the Illinois state budget in FY27 and that a maintenance budget is a best case scenario for the coming year. Pressures are expected from pension costs, Medicaid cuts, and other federal funding issues including mass transit.

Three bills were signed into law by Governor Pritzker this month.

HB0042 Authorizes libraries to bill nonresident fees on a quarterly or biannual basis. This is effective immediately.

SB1550 Introduced by Secretary Giannoulias, this allows funds to be made available by the state to improve or enhance the security of libraries. This takes effect January 1, 2026.

Illinois Legislative Updates (cont.)

HB1910 Requires that libraries take reasonable steps to have staff trained and available to respond to an opioid overdose, including the administration of an opioid antagonist. Libraries must also receive opioid antagonists from a lawful source. This will take effect January 1, 2026. RAILS has asked Ancel Glink to create a memo outlining frequently asked questions about this new law and will share the finished product with the membership soon.

Casten to Visit Bolingbrook Service Center

Representative Sean Casten (IL-06) visited the RAILS Bolingbrook service center on August 6th to receive a tour of our delivery operation. Rep. Casten was joined by ILA President Carolyn Ciesla and Illinois State Library Director Greg McCormick. After completing the tour led by Director of Facilities and Delivery Mark Hatch, several RAILS staff participated in a conversation with the Congressman to discuss the current state of Illinois libraries and federal funding considerations.

I had the pleasure of presenting for Directors University on August in Bloomington with my colleague Leslie Bednar, Executive Director of the Illinois Heartland Library System, on the importance of Library Systems 5. With the retirement of long-time staff member Jody Rubel on July 18, the Deals & Discount team worked in July on transition planning, reallocating tasks, and conducting the hiring process for Jody's replacement. The Library Resource Specialists worked together to develop and review a transition plan, including temporary and long-term redistribution of responsibilities, and a timeline of upcoming tasks.


