#### **FOIA Requests**

The request is limited to readily available records without physically copying, scanning, or printing paper documents. Any editable electronic document is acceptable.

The specific information requested from your record-keeping system is:

- 1. First Name
- 2. Last Name
- 3. Position Title
- 4. Department
- 5. Direct Phone Number (if it does not exist, list main phone number with extension)
- 6. Business Cell Phone (if provided by Reaching Across Illinois Library System)
- 7. Email Address
- 8. Office Address (Address, City, State, Zip)

SmartProcure is submitting a commercial FOIA request to the Reaching Across Illinois Library System for any and all purchasing records from 4/2/2025 to current. The request is limited to readily available records without physically copying, scanning or printing paper documents. Any editable electronic document is acceptable.

The specific information requested from your record keeping system is:

- 1. Purchase order number. If purchase orders are not used a comparable substitute is acceptable, i.e., invoice, encumbrance, or check number
- 2. Purchase date
- 3. Line item details (Detailed description of the purchase)
- 4. Line item quantity
- 5. Line item price
- 6. Vendor ID number, name, address, contact person, and their email address
