## **Advocacy Committee Report - Chair Jean Carroll**

The committee met on September 11, 2025. The next meeting is on November 13, 2025.

Carolyn Kinsella, AISLE Executive Secretary, spoke on the topic of the current state of school libraries, the decrease in licensed school librarians in Illinois, and advocacy efforts AISLE has spearheaded. Kinsella noted that legislation is the best way to make improvements, and local advocacy is an important tool. Derucki gave an overview of the SLATE Project dashboard. The members discussed future committee meeting topics. Harris gave an update on the status of IMLS and reported on the legislation supported by ILA. ### Resource Sharing Committee Report – Jennifer Hovanec

Filapek shared that RAILS has launched a new interactive resource sharing map that can be broken down by library, library system, and county. On Wednesday, September 24, at 2:00 p.m., Grant Halter, Data Analysis Manager, will host a webinar to present the map's capabilities. There are plans to revise the 2019 Community College Library survey to gather information on how community colleges provide services to their residents and, more specifically, services to individuals without access to a public library. Barb Miller, Consortial Services Supervisor, gave an overview of Find More Illinois (FMI). Filapek reported that Illinois Public Act 104-0036 was

signed into law in August, authorizing Illinois public libraries and library districts to bill nonresident fees quarterly or biannually. Harris shared an update on federal funding and the Institute of Museum and Library Services (IMLS). Lastly, committee members discussed the current state of resource sharing at their libraries.
