Catalog Membership Grants

In November 2025, Rolling Meadows Library and Wauconda Area Public Library District were each awarded \$53,050 Catalog Membership Grants to join CCS. Strategic Planning for 2027-2029

RAILS is beginning to map out the process of updating our current strategic plan which ends in 2026. We will be conducting several one-on-one stakeholder interviews with partner organizations, including LLSAPs. We look forward to connecting with our partners to help shape our objectives for serving our shared members and will reach out as the process gets underway.

2026 IPLAR Updates and Reporting Guidance

L2 API Change

When L2 was initially developed back in 2020, we created an Application Programming Interface (API) and made it available to our partner organizations. In addition to retrieving data on events, users, and locations, the L2 API has provided the option for authorized API users to update L2. Over the last five years, this update feature of L2 has not been used by anybody except RAILS. As of February 1st, 2026, the ability to update information via the L2 API will be removed for non-RAILS users. This change does not affect the ability to retrieve information from L2, or to use L2 as a log in mechanism for websites.

L2 Upcoming Development Priorities

Each Spring, RAILS applies for a grant from the Illinois State Library to support the ongoing development and maintenance of the L2 platform. At the February 3 meeting of the L2G2 statewide advisory group we will discuss and begin to prioritize feature requests and other development needs so we can prepare for our FY2027 funding request. All L2 users are welcome to submit requests at any time during the year, but this is a particularly good time to let us know if you or your staff have any requests in mind for changes or new features.
