**Evaluation Methods Used:** The main testing tools and methods used were WAVE (Web Accessibility Evaluation Tool) from WebAIM, Colour Contrast Analyser (CCA), the ARC Toolkit, axe DevTools v4.17.1 Chrome extension, the JAWS (Job Access With Speech) screen reader from Freedom Scientific, and manual keyboard testing.
