Weiss Financial Ratings Online was evaluated using Chrome on a Windows 10 desktop computer. Axe DevTools and ANDI were used to scan the site. Assistive technologies used in this evaluation included the NVDA (screen reader) and the Windows screen magnification function as well as exclusive use of the keyboard to navigate and operate the site content and functionality.
