Only the web software was evaluated in this report, since there is no hardware, authoring tools or other non-web software associated with this product.

Evaluation Methods Used:

The product was evaluated, and continues to be regularly evaluated, via automated and manual testing. The product used for automated testing was the Axe Dev Tools, Version 4.125.0 on Chrome 146.0.7680.165. The manual tests were performed by three accessibility professionals employed by Ancestry. One tester is a Certified Professional in Accessible Core Competencies, and another is a Certified Professional in Web Accessibility, both certified through the International Association of Accessibility Professionals. The assistive technologies employed during manual testing included NVDA version 2025.3.3 and JAWS version 2026.2603.86 on Windows 11.
